AN ACT

To appropriate the sum of \$3,200,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1994, for the purpose of funding the construction, repair, renovation, expansion or other improvement to the medical facilities or acquisition of supplies or equipment in each of the States, prohibiting use of these funds for travel, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. The sum of \$3,200,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1994, for the purpose of funding the construction, repair,
- 5 renovation, expansion or other improvement to the medical facilities
- 6 or acquisition of supplies or equipment in each of the States. None
- 7 of the funds made available by this act may be used for travel.
- Section 2. The sum appropriated under section 1 of this act

All funds appropriated by this act shall be 2 allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (1)(a) of section 2 of this act shall be the Faichuk PWP Development Authority. The allottee for all other funds appropriated under this act shall be the President or the President's designee; PROVIDED, the allottee of the funds appropriated under subsection (3) of section 2 of this act shall be the Governor of the State of Yap. The allottees shall be responsible for ensuring that these funds, or so 12 much thereof as may be necessary, are used solely for the purposes 13 specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottees to obligate 14 15 funds appropriated by this act shall lapse as of September 30, 1995. Section 4. This act shall become law upon approval by the 16 17 President of the Federated States of Micronesia or upon its becoming 18 law without such approval. 19
