AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF MONIES OUT OF THE CONSOLIDATED FUND FOR RECURRENT EXPENDITURE FOR THE SERVICE OF THE YEARS ENDING 31 DECEMBER 2012 AND 2013

Short title

1. This Act may be cited as the Supplementary Appropriation (No. 1) Act 2013.

Authorisation of issue of \$2,044,555 from the Consolidated Fund

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$2,044,555 to be applied for recurrent expenditure to the service of the years ending 31 December 2012 and 2013.

Appropriation

3. The sum specified in section 2 shall be appropriated for the supply of the Head(s) of Expenditure specified in Column 1 of the schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.

EXPLANATORY M1MORANDUM

- 4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.
