AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF MONIES OUT OF THE CONSOLIDATED FUND FOR RECURRENT EXPENDITURE FOR THE SERVICE OF THE YEAR ENDING 31 DECEMBER 1992

Commencement: 1992

MADE by the Maneaba ni Maungatabu and assented to by the Beretitenti.

### SHORT TITLE

1. The Act may be cited as the Supplementary Appropriation Act 1992.

AUTHORISATION OF ISSUE OF \$603,220 FROM THE CONSOLIDATED FUND

2. The issue from the Consolidated Fund is hereby authorised of a sum of \$603,220 to be applied for recurrent expenditure to the service of the year ending 31 December 1992.

### APPROPRIATION

3. The sum specified in Section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.

## SUPPLEMENTARY APPROPRIATION ACT 1992

## EXPLANATORY MEMORANDUM

- 1. The Act charges upon the Consolidated Fund a sum, which is required for recurrent expenditure for the year ending 31 December 1992, in addition to the amount appropriated for that year by the Appropriation Act 1991.
- 2. The sums required is to provide for money expended in excess of sums already appropriated.
- 3. The Act provides that the additional amount charged shall be expended upon the service listed in the Schedule to the Act.
- 4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of Section 109(3) of the Constitution.
