### **Short title:**

This Act may be cited as the Supplementary Appropriation (No. 2) Act 2015. 1.

### Authorisation of issue of \$10,853,595 from the Consolidated Fund

The issue from the Consolidated Fund is hereby authorized of a sum of \$10,853,595 to be applied for recurrent expenditure to the service of the year ending 31 December 2015.

### **Appropriation**

The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.
