In exercise of the powers conferred upon me by sections 36(1) of the Constitution, I hereby direct and authorize, during my absence from Tarawa for a Pacific Islands Leaders' Conference to Washington DC from 3rd May 2007 to 14th May 2007, the Honourable Teima Onorio, Te Kauoman ni Beretitenti and Minister of Environment, Lands and Agricultural Development to discharge the following functions of the Office of Te Beretitenti over the said period:

- (a) The functions under section 48 of the Constitution (which relates to proceedings in Cabinet);
- (b) The functions under section 92 of the Constitution (which relates to Oath of office);
- (c) The functions under section 99 of the Constitution (which relates to appointments etc, of public employees);
- (d) The functions under the Public Order Ordinance;

THE REPUBLIC OF KIRIBATI PRICES ORDINANCE (CAP 75)

(Section 3(1)

PRICES (REGULATION) ORDER (NO.2) OF 2007

In exercise of the powers conferred upon me by section 3(1) f the Prices Ordinance (Cap 75), I hereby make the following Order —

1. Citation

This Order may be cited as the Prices (Regulation) Order (No. 2) of 2007.

2. Commencement

This Order shall be deemed to have entered into force on the 29th day of May 2007.

3. Maximum wholesale and retail prices

A commodity listed in Column 1 of the Schedule must not be sold —

- (a) within the Gilbert Group -
 - (i) by wholesale at a price in excess of the price specified in Column 2 for the quantity there specified; or
 - (ii) by retail at a price in excess of the price specified in Column 4 for the quantity there specified:
- (b) within the Line and Phoenix Groups -

- by wholesale at a price in excess of the price specified in Column 4 for the quantity there specified; or
 - (ii) by retail at a price in excess of the price specified in Column 5 for the quantity there specified:

or in a greater or lesser quantity in excess of a price proportionate to the price so specified.

4. Records to be kept

- (i) A person carrying on a business which includes the sale of a commodity to which this Order applies shall keep and maintain records relating to the commodity.
- (ii) The records referred to in subsection (1), and all commodities to which this Order applies shall be open to inspection by Price Control Officers at all times during usual working hours on working days.

5. Repeal

All previous Orders under section 3(1) of the Prices Ordinance (Cap 75) are hereby repealed.
