INCOME TAX ACT (No.9) 1990

INCOME TAX (NEW SCHEDULE 7) ORDER 2009

Section 134 (c), income Tax Act 1990

In exercise of the powers conferred under Section 134 (c) of the Income Tax Act (No9) 1990, the Beretitenti acting in accordance with the advice of Cabinet, hereby amends Schedule 7 made under section 75(b) of the same Act as follow: -

1. Citation

This Order may be cited as the Income Tax (New Schedule 7) Order 2009.

2. New Schedule 7

Schedule 7 to the Income Tax Act 1990 is repealed and the following Schedule is substituted-

"SCHEDULE 7"

(section 75(b)

Exempt income

- **a.** Income of an individual, company organization or other entity as may be specified by notice issued by the Minister, acting in accordance with the advice of the Cabinet, covering such period and to such extent as shall be specified in such notice.
- **b.** Income of an individual, company, organization or other entity that, by virtue of a written agreement between the individual, company, organization or entity (as the case may be) and the Government of Kiribati, is to be exempt from income tax and is approved by the Minister, acting in accordance with the advice of the Cabinet.

COMMISSION

Section 3(1), Commissions of Inquiry Ordinance (Cap.10)

To: Nei Makurita Baaro AKK, of Ambo; and Mr Tion Otang AKK, of Tebunia

WHEREAS, by virtu of section 3(1) of the Commissions of Inquiry Ordinance (Cap. 10), the Beretitenti may, whenever he deems it advisable, issue a commission appointing one or more commissioners and authorizing them to inquire into any matter in which an inquiry would be for the public welfare;

NOW THEREFORE I, Anote Tong, Beretitenti, by this commission:

- 1. APPOINT **Nei Makurita Baaro AKK** and **Mr Tion Otang AKK** as commissioners (the 'commissioners ('the Commissioners') to inquire into the circumstances of the capsizing of the *vessel Uean Te Raoi II* on Monday 13 July 2009 that resulted in the loss of over 20 lives;
- 2. AUTHORISE the Commissioners to:
 - a) Investigate, examine and analyse the circumstances leading to the capsizing of the *vessel Uean Te Raoi II* on Monday 13 July 2009;
 - b) Investigate and determine the respective roles played in the incident by: the proprietors, management and crew of *Uean Te Raoi II*; the Director of Marine and staff of the Marine Division of the Ministry of Communications; Transport and Tourism Development; and any other person considered relevant;

- Review, examine and evaluate the effectiveness of existing response mechanisms to search
 and rescue operations, including the effectiveness of actions taken after similar maritime
 incidents in the past;
- d) Determine whether any law may have been contravened, and recommend where appropriate, proper remedies;
- e) Make recommendations as to improvements that might be made to legislation, regulations and licensing conditions so as to strengthen compliance and minimize the occurrence of such incidents in the future;
- f) Make recommendations as to improvements that might be made to existing policies, processes and procedures so as to improve the effectiveness of search and rescue operations in the future; and
- g) Investigate, evaluate and report on whether there exist any other issues of concern in relation to the capsizing of Uean Te Raoi II.

3. DIRECT as follows:

- a) The Nei Makurita Baaro AKK shall be chairperson of the Commissioners;
- b) That the inquiry shall be held
 - i) in public
 - ii) as soon as practicable; and
 - iii) at such place on South Tarawa, and at such times as the Commissioners shall designate;
- c) That the Commissioners shall submit their written report on the result of their inquiry into each and all of the matters referred to in paragraph 2 above, as well as the reasons for their conclusions, within thirty (30) days of the commencement of the inquiry;
- d) That the Commissioners shall, in the performance of their functions, be assisted by:

i) Mr Natario Kiati, who is hereby appointed as secretary of the commission under

section 7 of the Commissions of Inquiry Ordinance (Cap. 10);

ii) Ms Tumai Timeon, who is hereby appointed to act as counsel assisting the

commission; and

iii) Capt. Iain M. Hill, Capt. Tim Burfoot and Mr Ian Lancaster who are

hereby appointed as experts assisting the commission.

e) That all ministries, civil servants, boards agencies and instrumentalities of the

Government of Kiribati shall assist the Commissioners to the fullest extent, in order that

they may discharge their functions without any hindrance whatsoever.
