PRICES (AMENDMENT) ORDER (NO. 7) OF 2009

In exercise of the powers conferred upon me by section 3(2) of the Prices Ordinance (Cap 75), I hereby make the following Order-

Citation

1. This Order may be cited as the Prices (Amendment) Order (No. 7) of 2009.

Commencement

2. This Order shall be deemed to come into operation on the 15th September, 2009

Amends Parts I and II of Prices (Regulation) Order (No.1) of 2009

3. Parts I and II of the Schedule to the Prices (Regulation) Order (No.1) of 2009 is hereby amended by deleting the wholesale and retail prices referring to Rice, Sugar, Flour and Irish Cake and the following new prices substituted-

CONSTITUTION

Section 36(1)

DELEGATION OF POWERS TO TE KAUOMAN NI BERETITENTI AND MINISTER OF COMMERCE, INDUSTRY & COOPERATIVES CERTAIN FUNCTIONS OF THE BERETITENTI WHILST ABSENT FROM 17 TO 29 SEPTEMBER 2009

In exercise of the powers conferred upon me by section 36(1) of the Constitution, I hreby direct and authorise, during my absence from Tarawa to attend the Sixty Fourth United Nations General Assembly in New York, the Honourable Teima Onorio, Te Kauoman ni Beretitenti and Minister of Commerce, Industry & Cooperatives to discharge the following functions of the Office of the Beretitenti:

- (a) The functions under section 48 of the Constitution (relating to proceedings in Cabinet);
- (b) The functions under section 92 of the Constitution (relating to oath of office);
- (c) The functions under section 99 of the Constitution (relating to the appointment, removal and exercise of disciplinary control of public employees);
- (d) The functions under the Public Order Ordinance;
- (e) The functions under the Proceedings By and Against the Republic Ordinance; and
- (f) The functions under the Government Borrowing and Guarantee Ordinance.

This authority shall take effect upon my departure from Kiribati on the 17th day September 2009, and shall cease on the 29th day of September 2009, or on my return to Kiribati, whichever shall occur first.
