Classification of Publication (Censorship) Regulation 1990

1. APPLICATION FOR REGISTRATION, ETC., OF PUBLICATION PREMISES.

- (1) An application under Section 28 of the Act for registration or renewal of registration of publication premises shall be in Form 1 of Schedule 1.
 - (2) An application referred to in Subsection (1) shall contain-
 - (a) the name and address of the applicant; and
 - (b) the name and address of the premises in respect of which registration is sought; and
 - (c) particulars of the prescribed activity proposed to be carried on in the premises.
- (3) The fee payable for an application under Subsection (1) is as specified in Schedule 2.

2. CERTIFICATE OF REGISTRATION OF PUBLICATION PREMISES.

A certificate of registration of publication premises shall be in Form 2 of Schedule 1.

3. APPLICATION FOR CHANGE OF PUBLICATION PREMISES.

- (1) An application under Section 31 of the Act for a change of publication premises shall be in Form 3 of Schedule 1.
 - (2) An application referred to in Subsection (1) shall contain—
 - (a) the name and address of the applicant; and
 - (b) the name and address of the publication premises registered; and
 - (c) the name and address of the proposed new premises; and
 - (d) particulars of the prescribed activity.
- (3) The fee payable for an application referred to in Subsection (1) is as specified in Schedule 2.

4. APPLICATION FOR CLASSIFICATION OF DECLARED PUBLICATION.

- (1) An application under Section 38(1) of the Act for classification of a declared publication shall be in Form 4 of Schedule 1.
- (2) The fee payable for an application referred to in Subsection (1) is as specified in Schedule 3.

5. APPLICATION FOR REVIEW OF DECISION ON CLASSIFICATION OF DECLARED PUBLICATION.

- (1) An application under Section 40(1) of the Act for a review of a decision on the classification of a declared publication shall be in Form 5 of Schedule 1.
- (2) The fee payable for an application referred to in Subsection (1) is as specified in Schedule 3.

6. APPLICATION FOR CLASSIFICATION OF A FILM.

- (1) An application under Section 45 of the Act for classification of a film shall be in Form 6 of Schedule 1.

7. APPLICATION FOR CLASSIFICATION OF ADVERTISING MATTER.

- (1) An application under Section 46 of the Act for classification of advertising matter shall be in Form 7 of Schedule 1.
- (2) The fee payable for an application referred to in Subsection (1) is as specified in Schedule 3.

- (1) A licence under Section 50 of the Act to publish a film shall be in Form 8 of Schedule 1.
- (2) A licence under Section 50 of the Act to publish advertising matter shall be in Form 9 of Schedule 1.
