## NOTICE MADE PURSUANT TO SECTION 9 (2) OF THE FORESTRY ORDINANCE 1936-1937 (NEW GUINEA, ADOPTED) DECLARING LAND TO BE ADMINISTRATION LAND.

## NOTICE.<sup>(1)</sup>

Forestry (Papua) Ordinance 1950 of the Territory of Papua.

WHEREAS by sub-section (2) of section 9 of the Forestry Ordinance 1936-1937 of the Territory of New Guinea, as applied to the Territory of Papua by the Forestry (Papua) Ordinance 1950, it is provided that the Administrator may, by notice in the Gazette, declare any land as to which timber rights have been acquired under sub-section (1) of the said section to be Administration Land for the purposes of the said Ordinance:

And whereas timber rights have been acquired under sub-section (1) of the said section as to the land described in the Schedule hereto:

Now therefore, I, Jack Keith Murray, Administrator of the Territory of Papua and New Guinea, do hereby declare the land described in the Schedule hereto to be Administration Land for the purposes of the said Ordinance.

## THE SCHEDULE.

An area of land situate north-west west south-west and south of D.A. 1725 (Subitana Ltd.) District 9 Central Division commencing at the junction of the Eworogo Creek and the creek which forms the eastern boundary of Portion 396 thence along the eastern north-eastern northern and north-western boundaries of Portion 396 thence bearing 322 degrees for 44 chains to the summit of Avarabe Peak (which bears 321 degrees from Kailakinumu Village) thence bearing 52 degrees for 58 chains along the crest of Moatinumu Range (through the summit of Figorife Peak which bears 337 degrees 30 minutes from Kailakinumu Village) to a gap in Moatinumu Range (which bears 349 degrees 30 minutes from Kailakinumu Village) thence bearing 93 degrees for 30 chains and 127 degrees 30 minutes for 27 chains and 53 degrees 30 minutes for 31 chains and 127 degrees 30 minutes chains along the crest of the range to the most northerly corner of D.A. 1725 thence along the north-western western and southern boundaries of D.A. 1725 to the south-eastern corner of D.A. 1725 thence bearing 180 degrees for 180 chains thence bearing 270 degrees for 67 chains to the summit of Gavada Peak (which bears 151 degrees from Kailakinumu Village) thence bearing 298 degrees for 194 chains generally along the north-eastern boundary of D.A. 219 and along the crest of a range (through the summits of Linaribe Amainabe Asabibe Elefa and Iobunibidodo Peaks which bears 160 degrees 30 minutes 172 degrees 30 minutes 180 degrees 45 minutes 187 degrees 45 minutes and 212 degrees 30 minutes respectively from Kailakinumu Village) thence bearing 0 degrees or 360 degrees for 40 chains thence bearing 57 degrees for 62 chains to the commencing point be all the given dimensions a little more or less containing an area of approximately 3,500 acres all bearings given being true bearings calculated on a magnetic north 5 degrees 30 minutes east of true north.
