ORDINANCES REVISION ORDINANCE 1951.(1)

No. 74 of 1951.

An Ordinance to repeal or to amend certain Ordinances and other Laws in force in the Territory.

B E it ordained by the Administrator of the Government of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Papua and New Guinea Act 1949-1950, as follows:—

Short title.

1. This Ordinance may be cited as the Ordinances Revision Ordinance 1951. (1)

Amendment of Ordinance, &c., of the Territory of Papua. 2. The Ordinance and Regulations of the Territory of Papua specified in the first column of the First Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Amendment of Ordinance, &c., of the Territory of New Guinea. 3. The Ordinance and Regulations of the Territory of New Guinea specified in the first column of the Second Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Amendment of Ordinance, &c., of the Territory of Papua-New Guinea. 4. The Ordinance and Regulations of the Territory of Papua-New Guinea specified in the first column of the Third Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Amendment of Ordinances of the Territory of Papua and New Guinea. 5. The Ordinances of the Territory of Papua and New Guinea specified in the first column of the Fourth Schedule to this Ordinance are amended as respectively specified in the second column of that Schedule.

Repeal.

6. The Ordinances and Regulations specified in the Fifth Schedule to this Ordinance are repealed.

Amendment and citation of The Courts and Laws Adopting Ordinance (Amended) of 1889 (Papua).

- 7.—(1.) The Courts and Laws Adopting Ordinance (Amended) of 1889⁽²⁾ of the Territory of Papua is amended as specified in the Sixth Schedule to this Ordinance.
