THE REPEALING RULES OF 1900 (QUEENSLAND, ADOPTED) IN THEIR APPLICATION TO THE TERRITORY OF NEW GUINEA.

RULES OF COURT.

As of Wednesday, the Tenth day of October, a.d. 1900.

I T is ordered by the Honourable Sir Samuel Walker Griffith, Knight Grand Cross of the Most Distinguished Order of St. Michael and St. George, Chief Justice of Queensland, and the Honourable Pope Alexander Cooper and the Honourable Patrick Real, Esquires, Justices of the Supreme Court of Her Majesty's said Colony, in pursuance and execution of all powers and authorities enabling them in that behalf as follows:—

Repeal.

1. So much of the Regulæ Generales, General Orders, Rules of Court, and Regulations, specified in the First Schedule hereunder as is now in force is hereby repealed and annulled, except as to any proceedings pending on the first day of January, 1901, as to which the provisions of The Rules of the Supreme Court of 1900 or The Criminal Practice Rules of 1900 are not applicable.

Abrogation.

2. The statutory provisions set forth in the Second Schedule to these Rules, so far as the same relate to the regulation of the sittings of the Court and of the Judges thereof sitting in Chambers, and the regulation of the pleading, practice, and procedure, in the Court, and any matters relating to such practice and procedure, or to the duties of the officers of the Court or to the cost of proceedings therein, are hereby abrogated except as in the last preceding Rule mentioned.

Saving.

- 3. The repeal and abrogation effected by these Rules shall not affect—
 - (1) Anything done or suffered before the commencement thereof under any of the Regulæ Generales, General Orders, Regulations, or Statutory provisions, hereby repealed or abrogated;
