Being an Act to amend the *Customs Tariff Act 1990,*

MADE by the National Parliament to be deemed to have come into operation on 22 November 1995.

1. AMENDMENT OF SCHEDULE 1.

**2. AMENDMENT OF SCHEDULE 2.**

Schedule 2 to the Principal Act is amended by repealing the reference to the following:-

" 44.03 Timber logs and poles in the rough, whether or not stripped of bark or sapwood, or roughly squared, of the following species:-

(a)	balsa, blackbean, cordia, ebony, rosewood, teak and all conifers;	46%	Banned
(b)	kwila, pencil cedar, planchonella;	46%	P & R
(c)	calophyllum, mersawa, tuna, walnut	36%	P & R
(d)	burckella, canarius, gluta, hopea and terminalia;	28%	P & R
(e)	all others	26%	P & R"
