## ALIENS ORDINANCE, 1911-1919.40

## An Ordinance to amend the Law relating to Aliens.

BE it enacted by the Lieutenant-Governor of the Territory of Papua with the advice and consent of the Levislative Coun-Papua with the advice and consent of the Legislative Council thereof as follows:—

1. This Ordinance may be cited as the Aliens Ordinance, 1911- Short title. 1919.(1)

3.—(1.) Real and personal property of every description may capacity of be taken acquired held and disposed of by an alien in the same aliens as to property. manner in all respects as a natural born British subject and a title Imp. 33 & 34 Vic. to real and personal property of every description may be derived through from or in succession to an alien in the same manner in No. 28, all respects as if he were a natural born British subject.

(2.) The provisions of sub-section (1.) of this section shall not entitle an alien to any right or privilege as a British subject except such rights and privileges in respect of property as are thereby expressly given to him.
