An Ordinance relating to Duties of Customs.

BE it enacted by the Lieutenant-Governor of the Territory of Papua with the advice and consent of the Legislative Council thereof as follows:-

- 1. This Ordinance may be cited as the Customs Tariff, 1915. (1) Short title.
- 2. The Customs Ordinance of 1909(2) (No. 34 of 1909) and the Incorporation. Customs Ordinance, 1913(2) (No. 16 of 1913) shall be incorporated and read as one with this Ordinance.
