

CUSTOMS TARIFF, 1941.⁽¹⁾

An Ordinance to amend the “Customs Tariff, 1934-1939.”

BE it ordained by the Legislative Council for the Territory of Papua, in pursuance of the powers conferred by the *Papua Act, 1905-1940*, as follows:—

Short title and citation.

1.—(1.) This Ordinance may be cited as the *Customs Tariff, 1941.*⁽¹⁾

(2.) The *Customs Tariff, 1934-1939,*⁽²⁾ is in this Ordinance referred to as the Principal Ordinance.

Amendment of Tariff.

2. The Second Schedule to the Principal Ordinance is amended as set out in the Schedule to this Ordinance except as to anything done before the commencement of this Ordinance and except as far as relates to any arrears of duty and except so far as may be necessary for the purpose of supporting or continuing any proceedings heretofore taken or to be taken after the commencement of this Ordinance and any article upon which duty is imposed and any article declared free of duty shall be deemed dutiable or free as the case may be in accordance with the Second Schedule as so amended.

Date from which imports are to become dutiable or free.

3. Where by this Ordinance any Duty of Customs is imposed upon any article or any article is declared free the article upon which duty is imposed or declared free of duty as the case may be shall be deemed to have been dutiable or free as on and from the fifteenth day of July, One thousand nine hundred and forty-
