CUSTOMS TARIFF (NO. 2), 1941.⁽¹⁾

An Ordinance to amend the "Customs Tariff, 1934-1941."

B^E it ordained by the Legislative Council for the Territory of Papua, in pursuance of the powers conferred by the *Papua* Act, 1905-1940, as follows:—

1.—(1.) This Ordinance may be cited as the Customs Tariff (No. 2), $1941.^{(1)}$

(2.) Section One of the *Customs Tariff*, 1941, is amended by omitting Sub-section (3.).

(3.) The Customs Tariff, 1934-1939,⁽²⁾ as amended by the Customs Tariff, 1941, is in this Ordinance referred to as the Principal Ordinance.

Date from which imports are to become free.

2. The Second Schedule to the Principal Ordinance is amended as set out in the Schedule to this Ordinance except as to anything done before the commencement of this Ordinance and except as far as relates to any arrears of duty and except so far as may be necessary for the purpose of supporting or continuing any proceedings heretofore taken or to be taken after the commencement of this Ordinance and any article declared free of duty shall be deemed free in accordance with the Second Schedule as so amended.

3. Where by this Ordinance any article is declared free of duty the article declared free of duty shall be deemed to have been free as on and from the twenty-fourth day of October, One thousand nine hundred and forty-one, at ten o'clock in the forenoon declared
