QUARANTINE ORDINANCE, 1938. (1) (2)

No. 14 of 1938.

An Ordinance relating to Quarantine.

BE it ordained by the Legislative Council for the Territory of Papua in pursuance of the Papua, in pursuance of the powers conferred by the Papua Act, 1905-1934, as follows :---

1. This Ordinance may be cited as the Quarantine Ordinance, short title. 1938,⁽¹⁾ and shall be incorporated and read as one with the Quarantine Ordinance, 1913-1937.

2. The place described in the Schedule hereto shall be a place Appointment of appointed a Quarantine Station for the purpose of the quarantine station. of persons.

3. No legal proceedings civil or criminal shall be instituted in Restriction on any Court of law by any person for or on account of or in respect of having undergone quarantine prior to the passing of this Ordinance in the place hereby appointed a Quarantine Station by reason of such place not then having been so appointed.

4. The Lieutenant-Governor⁽²⁾ may by Proclamation⁽³⁾ at any time suspend all or any of the provisions of this Ordinance.

5. This Ordinance shall be deemed to have commenced on the Commencement. twenty-eighth day of September, One thousand nine hundred and thirty-eight.

Suspension of Ordinance.
