### NOTICE.

It is hereby notified for general information that his Excellency the Acting Administrator in Council has declared the following roads to be "Main Roads" under the provisions of the *Roads Ordinance*, 1916.

"All those roads delineated and coloured red on a plan bearing the signature of the Acting Commissioner for Lands and dated the 20th day of August, 1917, and deposited in the office of the Department of Lands, at Port Moresby, being Musgrave Street, Douglas Street, Port Road, Ela Beach Road, and that part of Hunter Street between Douglas Street and Port Road all within the Township of Port Moresby, and further without the said Township the formed and partly metalled road from Lawes Road on the Eastern boundary of the said Township for a distance of about sixteen (16) miles to the left bank of Sapphire Creek."

### NOTICE.

His Excellency the Lieutenant-Governor directs it to be notified that the several roads hereunder described and now particularly described in the plans bearing the signature of the Commissioner for Lands and dated the twelfth day of December, 1930, and deposited in the office of the Director of Public Works at Port Moresby are in pursuance of the powers conferred by the *Roads Ordinance*, 1916, declared main roads within the meaning of that Ordinance.

- 1. The new foreshore road from the Electric Light Power House situated adjacent to the Public Baths, Granville West, to its junction with Lawes Road adjacent to its intersection with Spring Garden Road, Granville East, henceforth to be known as Lower Port Road.
- 2. The road from Spring Garden Road, Granville East, to the Public Cemetery, henceforth to be known as Lawes Road.
- 3. The road which continues on from Ela Beach Road, Granville West, from the point where it meets Lawes Road to what is known as Lifu's corner situated opposite the Koki Gaol, henceforth to be known as Healy Parade.
