Editorial

Ombudsman Commission pay tribute to pioneer Ombudsman

THE Chief Ombudsman, Chronox Manek has paid tribute to former Chief Ombudsmen, Ombudsmen and staff, who have worked tirelessly to uphold the integrity of the Commission, since independence, to what it is today.

In a small ceremony to commemorate the occasion, the Chief Ombudsman praised the work of those dedicated pioneer Ombudsmen, such as the late Sir Ignatius Kilage as the first Chief Ombudsman, the late Andrew Maino, one of the two first Ombudsman and Frank Hedges as the other first Ombudsman.

The Chief Ombudsman quoting from the first annual report of the Ombudsman Commission records said, "our appointments were made by the Governor-General of Papua New Guinea Dr. Sir. John Guise on 4 December 1975, and we were sworn in by the first Chief Justice, Sir. Sydney Frost, on 8 December, 1975," referring to the first appointments.

Mr. Manek said, 8 December 2008, was a very special occasion for the Ombudsman Commission of Papua New Guinea because it marked the Commission's 33rd anniversary in office, much to the sorrow of those officers who have since left the Commission.



He said the occasion was timely because it coincided with the Commission's 2008 Christmas get-together, which was celebrated on Saturday 13 December, 2008.

The Members of the Commission and staff witnessed the cutting of a cake to commemorate the occasion and the two most senior serving officers, Samoa Kedea, Senior Manager Support Services and Margaret Kila, Executive Secretary to the Chief Ombudsman and a visiting Commonwealth Ombudsman officer, David Ward, to demonstrate our partnership with the Commonwealth Ombudsman and sister organizations were given the honour to cut the cake.


pictures above depict.

News in Brief

Lae office close for business

An unfortunate incident occurred on 9 December, 2008, when headquarters had to sanction Lae Regional Office to vacate its premises for the safety of its officers. Aston Brunswick which manages Vele Rumana issued instructions to all its tenants including the Ombudsman Commission that the building was closed for an indefinite period while investigations were being carried out to determine the extent of damage caused by the fire.

The burning down of the Best Buy building next door had caused widespread toxic smoke creating havoc to occupants of nearby buildings. Reports from our Regional Manager, Nao Virobo indicated that the situation was serious with heat from the burn causing cracks to the brick walls of the two buildings placing many innocent lives at risk.

Acting Secretary, Allan Barilae was tasked to monitor the situation until it got back to normal for business just before new year. No serious damages were reported.

Contract officers renew term

Eighteen senior officers of the Commission signed contracts of employment, most them renewal while a handful were new contracts on Friday 5 December, 2008.

The signing ceremony was presided by Chief Ombudsman, Chronox Manek, witnessed by two of the Commission members, Ombudsman John Nero and Ombudsman Phoebe Sangetari while Counsel to the Commission, Virgil Narokobi

facilitated the swearing in of oath.

The Chief Ombudsman praised the efforts of individual contract holders for fulfilling their contract obligations during their tenure.

Mr. Manek acknowledged contract officers who held senior positions in various capacities in the Commission for their continued commitment.

Similar sentiments were echoed by Ombudsman, John Nero and Ombudsman Phoebe Sangetari who gave supporting words of encouragement to the contract officers.

Australian Government Solicitor pro bono legal services

The office of the Commonwealth Australian Government Solicitor (AGS) would like to advise all Pacific Ombudsmen of its Pro Bono Legal Services Program. Under this program, approved legal projects can be provided with free-of-charge AGS legal services up to a specified limit. In past years, AGS has undertaken pro bono legal work in Australia and overseas. AGS is conscious of its pro bono obligations and is presently seeking to expand the assistance it provides, including to the Pacific region.

AGS legal services cover an extensive range including:

- Legal training
- Administrative law
- Legal policy development,
- Legislative review, reform and drafting,
- Statutory interpretation,
- Commercial agreements,

- Litigation processes and procedures,
- Constitutional issues.

AGS understands that each Pacific Ombudsman will possibly be aware of areas within Ombudsman jurisdiction or more broadly which may be able to benefit from AGS legal assistance.

In relation to such areas, AGS would be happy to discuss possible legal services projects which any Ombudsman may wish to raise with us. From an AGS perspective, projects of a short to medium term duration would be most suitable, given that AGS pro bono funds are limited.
