## Chief Ombudsman receives prestigious award

Chief Ombudsman Ila Geno was the proud recipient of the prestigious Siaguru Integrity Award for his outstanding leadership in fighting corruption at all levels of government and community.

This honor was accorded to Mr. Geno in December 2007 at a ceremony that coincided with Transparency International's 10th anniversary celebration in Port Moresby during which the Chief Ombudsman was given exceptional praise.

In commending the achievement Transparency International Chairman Mike Manning said the award was the first of its kind since the inception of TIPNG and had been established to honor individuals and organizations that have demonstrated exceptional courage and outstanding leadership in fighting corruption.

Mr Manning said Mr Geno was a deserving individual who was recognized for his determination and bravery in fighting corruption and the award was meant to mark the legacy of the esteemed founder Sir Anthony Siaguru and other like minded individuals such as Mel Togolo, Richard Kassman, John Nongorr and Dame Meg Taylor who started the TIPNG 10 years

## Tonga to set up Anti-Corruption Commission

NUKUALOFA, Tonga (Matangi Tonga, Feb. 23, 2008) -An Independent Anti-Corruption Commission will be set up and it should be in operation before the end of the year, according to the Solicitor General Linda FolaumoeLinda said that the commission would have extensive power, "to investigate suspected corruption, and prosecute civil servants of wrong doing."

The establishment of the Commission is co-funded by the Australian Government, and the position of a commissioner is currently being advertised. A commissioner should be announced by March.

The Solicitor General supported the move by government to establish an independent Anti-Corruption Commission.

She said that the Commissioner would be assisted by nine deputies who will investigate suspected corruption of any person or authority that was brought to the Commission's attention by a complainant.

Linda pointed out that an Anti-Corruption Commission Act 2007 had been passed, detailing the functions of the Commission, as well as the nature of corrupt conduct in relation to a minister of the Crown, a government official and a member of the Legislative Assembly.

The Act also allows for the Commission to have powers not only to investigate but to bring charges against suspected people."
