# LJSP Games ends in high note

This were the closing remarks given by the Chief Ombudsman at the one-day LJSP games held at the Sir John Guise sport stadium on Saturday 14 February, 2009.

The Chief Ombudsman alluded the success of the games to all those who have helped to make the games possible.

Mr. Manek said, had it not been for their leadership, co-ordination and guidance throughout the games it would not have been possible for us to be here.

Investigators urged to be neutral in their conduct



A three day investigators refresher course was conducted for officers of the Commission from Wednesday 18 to Friday 20 February 2009, courtesy of the Complaints Administrative and Investigations Division.

CAID acting Director, Joseph Molita, in his opening remarks welcomed participants, particularly officers who travelled in from the regions.

Mr. Molita said time management was an important topic for the workshop to dwell on, and therefore, they had to start on time, break on

time and finish each day on time.

He said workshop details would be progressed with the course facilitator, David Ward, who would be facilitating in the next three days.

Ombudsman John Nero, who officiated at the opening ceremony, welcomed everyone present, including new faces he had not been able to meet.

Mr. Nero encouraged participants to show professionalism in the conduct of their duties as investigators as this would determine the level of competency of officers, whether at headquarters or in the regions.

He called on participants to be more determined and conduct themselves impartially when they deal with cases.

"As investigators you are not advocating for anyone's call, not the complainants, not the government. You must be neutral at all times," he urged the participants.

Mr. Nero wished them luck throughout the three

day workshop and encouraged them to ask as many questions as they could possible can if they were not sure of issues being discussed.

He said by asking questions they can be able to get appropriate answers to issues they do not understand and this was the only healthy way of getting something out the workshop.

Mr. Nero said for officers in the regions, it will assist them advance in the way they conduct business for the Commission away from headquarters and urged them to make use of every opportunity available to them.

## Alotau takes lead in LJS exhibition—Kanekane

A three day Law and Justice Sector exhibition was staged in Alotau, the provincial capital of Milne Bay, from Wednesday 25 to Friday 27 February, 2009, at the Alice Wedaga Oval.

The Member for Samarai-Murua, Hon. Gordon Wesley (MP) who officiated at the opening ceremony highly praised the efforts of the Law and Justice Sector Programme for bringing the exhibition to Alotau.

Mr. Wesley said addressing law and order was not a Law and Justice Sector function alone, but needed communal participation so that it's impacts could be widely achieved, particularly at the grassroots level.

He said although, Alotau was a very peaceful province, compared to the rest of the provinces in Papua New Guinea, every caution was needed to ensure the influx of people into the province was carefully scrutinised.

Similar sentiments were also echoed by the Law and Justice Sector Programme Director, Joe Kanekane during his closing remarks alluding the province's success to the administrations recognition of the Law and Justice Sector's outreach programmes.

Mr. Kanekane reaffirmed the sectors full commitment for a safe, sound and just society for Alotau and maintained a strong bond between the administration and the Law and Justice Sector initiatives.

He alluded that it was the responsibility of every citizen in the country to understand the basic things in life. "That means if you learn to obey the law, learn not to break the law and respect the simple law, we will have a safe, sound and just society encapsulated in our slogan. Simple things like, if you are a betel nut chewer, learn to put your rubbish in the rubbish bins provided. If you are living next door to a person or family, you must respect their rights by turning the volume of your radio down. While we are talking about big things, the application of the rule of law must apply in your own setting."

Mr. Kanekane said if we can learn to do little things this we will go a long way in getting ourselves organised by concentrating on big things like chasing up criminals and putting them behind bars.

"Alotau is a good place and will continue to be a good place to live in and I am very honoured to be here, in fact, my first in my capacity as the Sector's Director. That is why I am very thankful", he added.

He said he was looking forward to working closely with the Administration and the NGO's to enhance the objectives of the Law and Justice Sector programmes in the months ahead.
