OCPNG and CO Twinning Review Program Meeting

7he Ombudsman Commission of Papua New Guinea and the Commonwealth Ombudsman held its Twinning Review Meeting Program from the 6th – 9th December 2010 at OCPNG head office in Port Moresby.

Chief Ombudsman Chronox Manek in his welcome and opening remarks said OCPNG has a very special relationship with CO. He said this replica is a positive indication because of the kind of job both Ombudsman Commissions do.

Ombudsman Sangetari also added that From right Deput OCPNG values very much the relationship making his responsible have with CO. Through this placement program they can learn from each other and have exposure in dialogue from the placements on both offices.

The officers were so grateful for the opportunity given to them by the Commission to participate in the twinning program. They have learnt a lot and are keen to put into practice their achievements and whatever skills acquired.





WORLD AIDS DAY HIGHLIGHTS...

Hundreds of people flocked to the Somare Foundation as early as 6 o'clock for a walk to commemorate the World Aids Day on 1 December 2010.

The theme of this year's walk was "Testim Na Tritim. Em Rait Bilong yu."

The walk started at around 7 o'clock from the Somare Foundation to the Sir John Guise stadium. It was a sea of red as people braved the morning heat walking up the Sir John Guise stadium and along the Waigani drive down the Cameron road towards the stadium.

OCPNG visits POM General Hospital

Officers from the Ombudsman Commission led by Ombudsman Phoebe Sangetari ended the World Aids day with a short visit to Ward 4A at the Port Moresby General Hospital on 1 December 2010.

They presented gifts donated through the 'Red Box' appeal that was launched in the office on November 4. The two boxes were filled with clothing, food and toiletries by the OCPNG staff.

When presenting the gifts Ombudsman Sangetari said the 'Red Box' was a token from the office of the Ombudsman to the hospital. She said apart from the office's role of dealing with constitutional matters, it also looks at human rights issues.

She said as the theme of the World Aids day stated *Universal* access and human right, the patients have the right to access basic needs such as food and clothing.

This was the first time for OCPNG to pay such visit and Ombudsman Sangetari has pledged to make this an annual event.

Dr. Lloyd Ipai and Sister in Charge Sr. Novete were so grateful of the donations. Dr. Ipai when thanking OCPNG staff said it was a timely visit as patients were very much in need of those basic needs.
