Liquor (Licensing) Act 1963

PROHIBITION OF SUPPLY OF LIQUOR

I, JOHN GUISE, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 124 of the *Liquor* (*Licensing*) Act 1963 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby—

(a) prohibit the supply of liquor under any licence or permit throughout Papua New Guinea-

(i) on a day which is a public holiday; and

(ii) on a Saturday and Sunday when the preceding Friday or the following Monday is a public holiday; and

(b) notwithstanding anything in this notice each holder of a publican's licence, limited hotel licence or residential club licence may supply liquor for consumption on licensed premises at any time to lodgers. In this notice "public holiday" means a day which is a public holiday under the *Public Holidays Act* 1953. Dated this sixteenth day of December, One thousand nine hundred and seventy-five.

Liquor (Miscellaneous Provisions) Act 1973

DECLARATION OF PUBLIC PLACES

I, PITA LUS, Minister for Corrective Institutions and Liquor Licensing, by virtue of the powers conferred by Section 9 of the Liquor (Miscellaneous Provisions) Act 1973 and all other powers me enabling, hereby declare all public places in Papua New Guinea to be public places to which the provisions of Section 9 of that Act apply, other than premises which are the subject of a licence or permit under the Liquor (Licensing) Act 1963, on a day which is a public holiday and on a Saturday and Sunday when the preceding Friday or the following Monday is a public holiday.
