PROHIBITION AND RESTRICTION OF SUPPLY OF LIQUOR AND DECLARATION OF PUBLIC PLACE I THOMAS KINGSTON CRITCHLEY, High Commissioner, by virtue of the powers conferred by Section 124 of the Liquor (Licensing) Act 1963, as amended to date, and Section 3 of the Liquor (Miscellaneous Provisions) Act 1973, as amended to date, and all other powers me enabling, and having received the advice of the Executive Council, hereby—

- (a) declare all public places in Papua New Guinea to be public places to which the provisions of Section 9 of the Liquor (Miscellaneous Provisions) Act 1973, as amended to date, apply on 28th, 29th, 30th and 31st (inclusive) March, 1975; and
- (b) prohibit the supply of liquor under any licence or permit throughout Papua New Guinea on 30th March, 1975; and
- (c) prohibit the supply of liquor under any licence or permit throughout Papua New Guinea on 29th March, 1975 and 31st March 1975, except between the hours of 12 noon and 2 p.m. (inclusive) and 6 p.m. and 8 p.m. (inclusive); and
- (d) notwithstanding anything contained in paragraph (c), prohibit the supply of liquor under any licence relating to dealers, bottleshops, storekeepers, and under any permit or occasional licence on 29th and 31st (inclusive) March, 1975; and
- (e) notwithstanding anything in this notice the holder of a publican's licence, limited hotel licence or residential club licence may sell, supply and dispose of liquor on licensed premises at any time to lodgers by way of room service.

DETERMINATION M.P.S. No. 2 of 1975

CONDITIONS OF SERVICE (AMENDMENT) DETERMINATION 1975,

A DETERMINATION to amend the Members of the Ministerial Personal Staff (General Conditions of Service) Determination 1973, as amended to date, made by the Chief Minister, after consultation with the Public Service Board, under the Ministerial Personal Staff Act 1972, as amended to date.

1. REPEAL AND REPLACEMENT OF SECTION 6.

Section 6 of the Principal Determination is repealed and the following sections inserted in its place:—
"6.—SALARIES.

Subject to Sections 6A and 8, the salary payable to a member of the ministerial personal staff occupying a position specified in Column 1 of the Schedule is the minimum salary payable, from time to time, to an officer of the Public Service occupying an office specified opposite in Column 2 of that Schedule.

"6A,-MINISTER MAY GRANT INCREASES IN SALARY.

- (1) Where a Minister is of the opinion that the services of a member of his personal staff warrant it, the Minister may, by notice in writing to the Assistant Secretary (Ministerial Services) Department of the Chief Minister and Development Administration, direct that the salary of the member be increased by an amount up to but not exceeding the difference between the salary payable to the member under Section 6 and the maximum salary payable to an officer of the Public Service occupying that position in the Public Service.
- "(2) In this section "Minister" includes Leader of the Opposition and Deputy Leader of the Opposition.".
