AMENDMENT OF NOTICE OF SUSPENSION ORDER

I, JOHN GUISE, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 9D of the *Provincial Government* (*Preparatory Arrangements*) Act 1974, as amended to date, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby amend the notice of Suspension Order dated 15th October, 1975 and published in *National Gazette* No. 11 of 16th October, 1975, by—

- (a) omitting the name "Philip Bouraga" specified in Column 1 of the Schedule and inserting in its place the name "Jack Karukuru"; and
- (b) omitting the name "Jack Karukuru" specified in Column 2 of the Schedule and inserting in its place the name "Benson Gegeiyo"; and
- (c) adding at the end of Column 1 of the Schedule the name "Joseph Tonnaku"; and
- (d) adding at the end of Column 2 of the Schedule the name "James Rutana".

DECLARATION OF APPLICATION OF DIVISION II.1 OF THE ACT TO CERTAIN PARTS OF PAPUA NEW GUINEA
