## **PRICES ORDER No. 172**

being

A Prices Order relating to the maximum retail price for

## **AVIATION GASOLENE**

MADE by the Deputy Price Controller under the provision of the Prices Regulation Act 1949, to come into operation on the date of publication in the National Gazette.

## 1. CITATION.

This Order may be cited as Prices Order No. 172.

## 2. REVOCATION.

Prices Orders Nos 158 and 159 are hereby revoked.

## 3. DEFINITIONS.

In this Order—

"aviation gasolene" includes any substance normally sold as aviation gasolene whether or not containing additives of any kind;

"supplier" in relation to aviation gasolene, means a person or a firm who sells aviation gasolene for the purpose of consumption or use;

"retail" means for the purpose of consumption or use.

# 4. MAXIMUM RETAIL PRICE.

- (i) Where aviation gasolene is supplied at a locality specified in Column 1 of Schedule I, the maximum price a gallon at which the aviation gasolene may be supplied is the maximum retail selling price specified in Column 2 of that Schedule in relation to the locality concerned; and
- (ii) Where the maximum price of any quantity of aviation gasolene, supplied at any one time, calculated in accordance with Subclause (i) is an amount involving a fraction of a toea, the supplier may charge to the next whole toea; and
- (iii) Where aviation gasolene is supplied at a locality specified in Column 1 of Schedule II, the maximum surcharge for each aircraft, specified in Column 2 of that Schedule in relation to the locality concerned may be charged by the supplier in addition to the maximum retail selling price specified in Subclause (i).

## 5. SUPPLY TO GOVERNMENT.

Nothing in this Order applies to or relates to the supply of aviation gasolene to the Government or instrumentality or authority of the Government.

Apprenticeship Act 1967

## DETERMINATION

THE Apprenticeship Board, by virtue of the powers conferred by Section 21 of the Apprenticeship Act 1967 and all other powers it enabling hereby revokes the Determination dated 21st January, 1974 and published in Government Gazette No. 9 of 31st January, 1974 and determines, in respect of each of the apprenticeship trades specified in the first column of the Schedule hereto the minimum standard of educational qualifications required for entry into that apprenticeship trade to be the qualifications specified in the second column of that Schedule opposite to the apprenticeship trade in the first column.
