APPOINTMENT OF OFFICERS TO APPROVE REQUISITIONS

I, Julius Chan, Minister for Finance, by virtue of the powers conferred by Section 29 of the Public Finances (Control and Audit) Act 1973 and all other powers me enabling, hereby-

- (a) revoke the notice of Appointment of Officers to Approve Requisitions dated 10th February, 1976 and published in National Ĝazette No. G15 of 13th February, 1976; and
 - (b) revoke the notice of Appointment of Officers to Approve Requisitions dated 21st May, 1976 and published in National Gazette No. G41 of 26th May, 1976; and
 - (c) appoint each officer specified in Column 1 of the Schedule to approve requisitions for the expenditure of moneys in accordance with a warrant authority for a purpose specified in any other column of the Schedule to an amount not exceeding the amount (in kina) specified in that column opposite the designation of the officer, subject to the qualifications (if any) specified in a footnote to that amount,
