  - (a) appoint Monday, 12th June, 1978 to be a public holiday throughout Papua New Guinea to commemorate the birthday of the Sovereign; and
  - (b) appoint-
    - (i) Saturday, 16th September, 1978; and
    - (ii) Monday, 18th September, 1978,

respectively, to be a public holiday throughout Papua New Guinea to commemorate the attainment by Papua New Guinea of Independent Sovereign Nationhood.
