- I, John Guise, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 17 of the Banking Corporation Act 1973 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby-
 - (a) revoke the Notice of Terms and Conditions of Service of W. H. Clark as Managing Director dated 13th December, 1973 and published in Government Gazette No. 114 of 20th December, 1973; and
- (b) determine that the terms and conditions of service of William Henry Clark as the Managing Director of the Papua New Guinea Banking Corporation are as set out in the Schedule to this Determination, to come into effect on and from 14th February, 1977.
