STATUTORY INSTRUMENT

No. 10 of 1977.

Electoral Regulation 1977,

Being a Regulation,

MADE by the Head of State, acting with, and in accordance with, the advice of the National Executive Council, under the Organic Law on National Elections.

1. - INTERPRETATION.

- (1) In this Regulation, unless the context otherwise requires, or some other meaning is clearly intended -
  - "the Law" means the Organic Law on National Elections.
- (2) A reference to a form by number shall be read as a reference to a form so numbered in the Schedule.
- 2. FEE FOR COPY OF ELECTORAL ROLL.

The fee for a copy of the latest print of -

- (a) an electorate Roll shall be K10.00; and
- (b) all supplemental prints shall be K2.00.
- CLAIM FOR ENROLMENT.
- (1) Where the Electoral Commission so directs a claim for enrolment shall be in Form 1.
  - (2) A witness to a claim for enrolment shall be -
    - (a) an elector; or
    - (b) a person who is qualified to be an elector.
- 4. CLAIM FOR TRANSFER OF ENROLMENT.

A claim for transfer of enrolment shall be in Form 2.

5. - CHANGE OF ADDRESS, ETC. A claim for -

- (a) alteration of enrolled address within the same electorate; or
- (b) correction of name, address or occupation of the elector,

shown on the electorate Roll shall be in Form 3 and shall be witnessed by an elector or a person who is entitled to be an elector.

6. - INQUIRY BY RETURNING OFFICER.

- (1) The Returning Officer may, subject to the direction of the Electoral Commission, make inquiries as to the names of persons entitled to be enrolled, but who are not enrolled, or who have changed their place of living from one address in the electorate to another address in that electorate without notifying the Returning Officer.
- (2) Where the Returning Officer is satisfied that a person has failed to comply with the provisions of Section 56 of the Law, he may notify him of the non-compliance in Form 4.
- (3) A person may reply to a notice under Subsection (2) in Form 5.
  - (4) Where a person -
    - (α) fails to reply to a notice under Subsection(2); or
      - (b) does not reply to a notice under that subsection in a satisfactory manner,

the Returning Officer may, with the consent of the Electoral Commission, institute proceedings against that person.

- 7. NOTICE OF TRANSFER.
  A notice of transfer of enrolment shall be in Form 6.
- 8. REJECTION OF CLAIM.
  - (1) A notification of rejection of -
    - (a) a claim for enrolment; or
    - (b) transfer of enrolment,

shall be in Form 7.

- (2) A notification under Subsection (1) shall be -
  - (a) sent to the claimant at the postal address; or
  - (b) delivered to the place of residence,

shown on his claim.

9. - OBJECTION.

(1) Where an objection to a name on a Roll is in writing it shall be in Form 8.

Electoral No. 10 1977

- For the purposes of Sections 66 and 67 of the Law, Assistant Returning Officers are prescribed officers.
- 10. NOTICE OF OBJECTION. (1) For the purposes of Section 68(2) of the Law, where a notice of objection to a name on a Roll is in writing it shall be in Form 9.
- (2) The answer to a notice of objection under Subsection(1) shall, where it is in writing, be signed by the person to whom the notice is directed, in the presence of a witness who shall be -
  - (a) an elector; or
  - (b) a person qualified to be an elector.
- (3) An answer to an objection shall be given or delivered, as the case may be, to the Returning Officer for the electorate to which the Roll relates.
- 11. NOTICE OF DETERMINATION OF OBJECTION.
- (1) A notice of the determination of an objection by the Returning Officer may be in Form 10.
  - (2) A notice under Subsection (1) -
    - (α) removing the name of the person objected to; or
    - (b) dismissing the objection.

shall be delivered or posted by registered post to the last known place of residence of the objector or the person objected to or both, as the case requires.

- 12. APPLICATION, ETC., TO DISTRICT COURT.
  - (1) An application to the District Court for an order
    - directing that the name of an elector be enrolled or reinstated on the Roll, as the case requires, under Section 71(1) of the Law; or
    - sustaining an objection under Section 71(2) of the Law,

shall be in writing.

- (2) An application under Subsection (1)(b) shall be lodged within two months after the determination of the objection.
- (3) Service of notice of application under Section 71(3) of the Law shall be delivered or posted by registered post to the last known place of residence of the objector or the person objected to, as the case requires.
- 13. NOMINATION.

The nomination of a candidate for election shall be in Form 11.

14. - TELEGRAM NOTIFYING NOMINATION.

A telegram from an Assistant Returning Officer or \_

authorized person to the Returning Officer for the electorate notifying nomination of a candidate shall be in Form 12.

15. - WITHDRAWAL OF NOMINATION.

A notice of withdrawal of nomination of a candidate -

- (a) shall be in Form 13; and
- (b) shall be signed before -
  - (i) the Returning Officer; or
  - (ii) the Assistant Returning Officer; or
  - (iii) a person authorized for that purpose by the Returning Officer.
- 16. TELEGRAM NOTIFYING WITHDRAWAL.

A telegram from an Assistant Returning Officer or authorized person to the Returning Officer for the electorate notifying the withdrawal of nomination of a candidate shall be in Form 14.

17. - APPLICATION BY 18 YEAR OLD PERSON FOR POSTAL VOTE CERTIFICATE, ETC.

An application by a person becoming 18 years of age after the issue of the writ and before the end of the polling period for a postal vote certificate and postal ballot-paper shall be in Form 15 and shall be witnessed by an elector or a person who is entitled to be an elector.

18. - POSTAL VOTE CERTIFICATE, ETC.

A postal vote certificate and declaration by an elector shall be in Form 16.

- 19. BALLOT-PAPERS.
- (1) Where in an election in an electorate there are, at the hour of nomination, more than one but not more than 15 candidates, and the Electoral Commission certifies, by notice published in the National Gazette, that -
  - (a) each of the candidates has supplied a photograph approved by the Electoral Commission as being suitable for reproduction on a ballot-paper;
     and
  - (b) it is practicable to use, in the election, ballot-papers in Form 17 including photographs of each of the candidates,

the ordinary ballot-papers to be used in that election shall be in Form 17 including a photograph of the head of each of the candidates taken from the photographs supplied, positioned as shown on that form.

- (2) Where a candidate fails to supply a photograph approved by the Electoral Commission under Subsection  $(1)(\alpha)$ , the Electoral Commission may arrange for a photograph of the candidate to be taken suitable for inclusion in the ballot-paper.
- (3) The photographs shall be reproduced in the manner and form approved by the Electoral Commission, and the Electoral

Commission may exclude from them any material that is, in his opinion, extraneous or irrelevant to the matter of identifying the respective candidates.

- (4) In any case where Subsection (1) does not apply, the ordinary ballot-papers to be used in the election shall be in Form 18.
- (5) Postal ballot-papers to be used in the election shall be in Form 19 or 20.
- 20. DECLARATION WHERE NAME NOT ON CERTIFIED LIST.

A declaration by a person to whom Section 141 of the Law applies shall be in Form 21.

21. - DECLARATION WHERE NAME HAS BEEN MARKED.

A voter shall before he is permitted to vote under Section 142 of the Law make a declaration in Form 22.

22. - DECLARATION BY PERSON NOTED AS PERSON TO WHOM POSTAL

CERTIFICATE, ETC., ISSUED.

A declaration by a person to whom Section 143 of the Law applies shall be in Form 23.

23. - INSPECTION OF DOCUMENTS, ETC.

Inspection of Rolls and documents in connexion with any matter under Part XVIII of the Law shall be in the presence of the Returning Officer for the electorate to which the Rolls and documents relate.

24. - PRESERVATION OF BALLOT-PAPERS, ETC.

- (1) At the end of the polling period, the presiding officer at each polling place shall
  - place the certified list of voters for the polling place in a sealed parcel; and
  - endorse on the parcel a description of its
  - contents; and transmit the parcel to the Returning Officer with the least possible delay.
- (2) All ballot-papers, certified lists of voters and declarations in connexion with an election shall be preserved by the Returning Officer until the election can no longer be questioned.


