Defence Act 1974

#### APPOINTMENT OF ACTING COMMANDER OF THE DEFENCE FORCE

I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 193 of the Constitution and Section 11 of the *Defence Act* 1974 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council given after consultation with the Public Services Commission, hereby appoint Kenneth Kora Noga to act as Commander of the Defence Force during the absence from the country of Edward Ramu Diro for a period up to and including 20th March, 1977 (approximately).

Public Service (Interim Arrangements) Act 1973

#### APPOINTMENT OF ACTING DEPARTMENTAL HEAD

#### Law Reform Commission Act 1975

### TERMINATION AND APPOINTMENT OF SECRETARY TO THE LAW REFORM COMMISSION OF PAPUA NEW GUINEA

#### Customs Tariff 1959

#### NOTICE OF EXEMPTION FROM DUTY

- I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 5 of the Customs Tariff 1959 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council hereby exempt from duty for the period specified the following goods:—
  - (a) glassware manufactures being glass jars with a capacity of 250 ml and their closures—until 30th April, 1977; and
  - (b) glassware manufactures being glass jars with a capacity of 150 ml and their closures—until 31st December, 1977,

that are declared by the importer to be and that the Comptroller is satisfied are for use solely in the manufacture in Papua New Guinea of peanut butter.

#### Liquor (Miscellaneous Provisions) Act 1973

#### EXEMPTION FROM PROHIBITION ON ADVERTISING

- I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 6 of the Liquor (Miscellaneous Provisions) Act 1973 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt any advertisement, statement, writing, notice, photograph or picture containing—
  - (a) words or letters being, or indicating, the name or business name of a brewery; or
  - (b) devices, signs or symbols used by a brewery at the date of publication of this notice in the National Gazette,

from the provisions of Section 5 of that Act (the operation of which has been extended so as to include ale, beer, porter, stout, cider and perry within the definition of "liquor" for the purposes of that section), on condition that these permitted advertisements, words, letters, devices, signs or symbols are not published in a manner which is intended or likely—

- (c) to promote the sale or disposal of liquor; or
- (d) to increase the purchase, consumption or use of liquor; or
- (e) to induce any person or persons to purchase, consume or use any liquor,

except to the extent that they may incidentally do so by having been associated with the sale or consumption of beer prior to the date of publication of this notice in the National Gazette.
