DECLARATION OF COMMON RULE

I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 36 of the Industrial Relations Act 1962 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby declare, in respect of the Notice of Intention to Declare Common Rule (Award No. 12 of 1975) dated 13th April, 1977 and published in National Gazette No. G34 of 14th April, 1977, the Papua New Guinea Trade Union Congress General Employment (Amending) Award (Award No. 12 of 1975) to be a com-mon rule varying each award specified in Column 1 of the Schedule and declared to be a common rule as specified in Column 2, in relation to each area specified in Column 3 and the following employees in each of those areas:-

- (a) all persons employed in each of those areas except employees engaged-
 - (i) directly in primary production; or
 - (ii) in domestic duties; or
 - (iii) under any other Act in force in Papua New Guinea other than those employees classified as General Labourers and Class 1, 2 and 3 occupations as determined by the Minimum Wages Board Determination No. 4 of 1974; and
- (b) employees (other than those excepted in paragraph (a)) normally employed in each of those areas but who are transferred by their employers from the area in the course of employment providing that such employment does not exceed six months or the period of a specific contract, whichever is the greater.

DECLARATION OF COMMON RULE

I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 36 of the *Industrial Relations Act* 1962 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, in respect of the Notice of Intention to Declare Common Rule (No. 13 of 1975) dated 13th April, 1977 and published in *National Gazette* No. G34 of 14th April, 1977, hereby

- (a) repeal the notice of Declaration of Common Rules dated 6th December, 1973 and published in *Government Gazette* No. 112 of 13th December, 1973 in so far as it relates to the Port Moresby General Employment Award 1973 (No. 16 of 1973); and
- (b) declare that Award as varied by the Port Moresby General Employment (Amending) Award 1975 (No. 13 of 1975) to be a common rule in relation to the area specified in Schedule 1 and the employees specified in Schedule 2 employed in that area.

SCHEDULE 1

4. MAXIMUM PRICES.

Notwithstanding the provisions of Prices Order No. 177, the maximum price per bird at which poultry may sold by wholesale and retail in the city of Port Moresby is the amount specified in Column 2 of the Schedule in relation to the size of each bird specified opposite in Column 1 of the Schedule.

5. DISPLAY OF PRICES.

A person or organisation who has in his custody or under his control any poultry for sale by retail, or who offers, exhibits or exposes any of that poultry for sale by retail, shall display a ticket, label, placard or notice attached to or exhibited or displayed with the poultry setting forth in a prominent position in clear and legible figures easily discernible to any person inspecting such poultry, the prices at which the poultry concerned may be bought.
