Imports (General Levy) Act 1970

EXEMPTION

- I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 11 of the *Imports* (General Levy) Act 1970 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from the General Import Levy imposed under Section 9 of that Act—
 - (a) any goods imported by, or on behalf of, or being the property of a Provincial Government (including any Local Government Council or Community Government Council, by whatever name known, established by a Provincial Government), Area Authority or Local Government Council, excluding business arms and other subsidiaries of those bodies; and
 - (b) any goods in the form of aid received from donor countries on a bilateral basis,

subject to the condition that those goods shall not, during the period of three years immediately following their importation, be sold to any person other than another Provincial Government, Area Authority or Local Government Council.

National Investment and Development Act 1974

NOTIFICATION OF APPROVAL OF REGISTRATION

- 3. The Enterprise will use sources of supply and services within Papua New Guinea, preferably Papua New Guinean owned, unless the required supplies and services are not readily available at comparable prices and similar quality in Papua New Guinea.
- 4. The Enterprise will keep all its books of account and records in Papua New Guinea and in the English language.
- 5. Subject to the Act, the registration of the Enterprise is for fifteen years from the date of registration but may be extended from time to time by the Minister on the application of the Enterprise.
- 6. Any application by the Enterprise for approval of, or a determination by, the Minister required by or to be given in accordance with any of these terms and conditions shall be made in writing to NIDA.

National Investment and Development Act 1974

NOTIFICATION OF APPROVAL OF REGISTRATION

IT is hereby notified in accordance with Section 54(12) of the National Investment and Development Act 1974 that—

(a) under Section 54(9) of the Act the Minister approved registration of Atlas Steel Pty Ltd (in this notification called "the Enterprise") in respect of the following activities:

I.S.I.C. No. 3710—Iron and steel basic industries

I.S.I.C. No. 3819—Manufacture of fabricated metal products except machinery and equipment not elsewhere classified

subject to the conditions specified in the Schedule; and

- 2. Any application by the Enterprise for approval of, or a determination by, the Minister required by or to be given in accordance with any of these terms and conditions shall be made in writing to NIDA.
- 3. The Enterprise shall keep all its books of account and records in Papua New Guinea and in the English language.
- 4. The Enterprise shall comply with all and any obligations and conditions relating to the employment of non-citizens, training of employees and the localisation of its staff (including both employees and officers of the Enterprise) which may from time to time be laid down by the Department of Labour, Commerce and Industry (or any other Department which succeeds to the functions of that Department) or be prescribed or declared under the Employment (Training and Regulation) Act 1971 or under any other Act dealing with employment of non-citizens, or training and localisation of employees.
- 5. Within twelve months of the date of registration the Enterprise shall submit to the Department of Labour, Commerce and Industry its Manning Plan together with its training and localisation schedule. The Enterprise shall not commence carrying on business unless the Minister approves its Manning Plan in writing.
 - 6. (a) Subject to the Act and to paragraphs (b), (c) and (d), the registration of the Enterprise is for a term of ten years from the date of registration.
 - (b) If at the expiry of the term of registration under paragraph (a):—
 - (i) Papua New Guineans or local enterprises are the beneficial owners of shares entitling them to not less than 26% of the voting power in the Enterprise and not less than 26% of the directors of the Enterprise are Papua New Guineans or nominees of local enterprises which are shareholders of the Enterprise; or
 - (ii) Papua New Guineans or local enterprises hold rights to purchase shares in the Enterprise which if exercised would make the aggregate shareholding of Papua New Guineans and local enterprises in the Enterprise not less than 26% of its issued share capital and the State or a Government-controlled corporation holds an option to purchase shares in the Enterprise up to 26% of its issued share capital if these shares are not purchased or taken up by Papua New Guineans or local enterprises;

the term of registration shall be extended.

- (c) The extension of the term of registration under paragraph (b) shall be:—
 - (i) Subject to subparagraph (ii), for five years; or
 - (ii) Until the conditions in paragraph (b)(i) and (ii) have ceased to apply for a period of six months.
- (d) The term of registration may be extended or further extended from time to time by the Minister on the application of the Enterprise but any extension under this paragraph shall be subject to such additional conditions as to share ownership, voting power and directors as the Minister may determine and notify to the Enterprise in writing when granting the extension.
- 7. Within six months of the date of registration the Enterprise shall submit to the Minister its Financial Plan. The plan shall cover a minimum period of five years and include all capital financing including the details of any loan agreements. The Enterprise shall not commence carrying on business unless the Minister approves the Financial Plan in writing and the issued share capital of the Enterprise is not less than that in the approved plan.
- 8. Within six months of the date of registration the Enterprise shall submit to the Minister full details of all management and technical assistance agreements to be entered into by the Enterprise. The Enterprise shall not commence carrying on business unless the Minister approves all these agreements in writing.
- 9. The Enterprise shall obtain the approval of the Minister in writing before commencing to manufacture for sale any products other than steel bars, rods (including wire rod), sections and wire but may galvanise any products manufactured in Papua New Guinea without prior approval.

Schedule-continued

- 10. The Enterprise shall inform NIDA not less than one month before applying for any form of subsidy or trade protection from the State.
- 11. If at the expiration of twenty-four months from the date of registration the Enterprise has not commenced carrying on business in any of the activities for which it is hereby registered, the registration of the Enterprise shall thereupon cease and determine in respect of those activities.
- 12. The Enterprise shall guide and assist Papua New Guinean enterprises in establishing business in ancillary activities.
- 13. The Enterprise shall use sources of supply and services within Papua New Guinea, preferably Papua New Guinean owned, unless the required supplies and services are not readily available at comparable prices and of similar quality in Papua New Guinea.
- 14. The Enterprise shall at all times conduct its operations in such a way as to minimise deleterious effects on the environment and shall abide by any reasonable standards specified by the Minister responsible for environmental matters.
 - 15. The Enterprise shall not without the prior approval in writing of the Minister:—
 - (a) require, as a condition of the supply of goods or services to another enterprise, that that enterprise acquire all or part of its requirements of goods or services of another class directly or indirectly from a second enterprise;
 - (b) induce another enterprise to refuse to deal with a second enterprise except on terms disadvantageous to the second enterprise; or
 - (c) impose prices or other terms or conditions of dealing that it would be unable to impose but for its dominant position in the market of Papua New Guinea.
 - 16. The Enterprise shall notify NIDA within thirty days of the registration of any transfer of its shares.
- 17. The Enterprise shall not without the prior approval in writing of the Minister carry on the activities for which it is registered in any location in Papua New Guinea other than Port Moresby.
