APPOINTMENT OF MEMBERS OF THE LAND BOARD

I, Boyamo Sali, Minister for Lands, by virtue of the powers conferred by Section 10(2) of the Land Act 1962 and all other powers me enabling, hereby appoint—

- (a) each person specified in Column 1 of Schedule 1 to be a member of the Land Board to act (subject to paragraph (b)) only in relation to land within the Province specified in Column 1 and set out opposite the name of that member for a period commencing on and from the date of signature of this instrument in the *National Gazette* up to and including 30th April, 1979; and
- (b) each person specified in Schedules 1 and 2 to be a member of the Land Board for the purposes of considering applications for land for cultivation of oil-palms at Special Land Board Meeting No. 1104 to be convened at various centres of Papua New Guinea for a period commencing on and from the date of publication of this instrument in the *National Gazette* up to and including 24th November, 1978.
