 - (iii) in the case of the First Secretary (Information)—the Vice-Consul (Administration), Papua New Guinea Consulate-General, Sydney; and
 - (d) determine that the limits of authority and jurisdiction of the Board shall be to invite tenders for-
 - (i) the purchase and disposal of stores; and
 - (ii) the supply of works and services, for and on behalf of the State to a value estimated by the Board not to exceed K100 000.00; and
 - (e) fix a quorum for a meeting to be three members of whom no more than one shall be a Deputy.". Dated this 7th day of March, 1979.
