### Liquor (Licensing) Act 1963

### RESTRICTION OF SALE AND SUPPLY OF LIQUOR

I, Delba Biri, Minister for Corrective Institutions, by virtue of the powers conferred by Section 31 of the Liquor (Licensing) Act 1963 and all other powers me enabling, hereby restrict, within the area specified in the Schedule, the sale or supply of liquor on premises which are the subject of a licence or permit under the Act, where that liquor is not for consumption on those premises, to the sale or supply on Monday, Tuesday, Wednesday and Thursday in each week for a period of 3 months commencing on and from the date of publication of this instrument in the National Gazette.
