National Investment and Development Act 1974

#### NOTIFICATION OF APPROVAL OF REGISTRATION

IT is hereby notified in accordance with Section 54(12) of the National Investment and Development Act 1974 that—

(a) under Sections 54(9) and 56(10) of the Act the Minister approved the registration of T. G. A. Pty Limited (in this notification called "the Enterprise") in respect of the following activities:

I.S.I.C. No. 8312—Manufacture of fixtures and furnitures primarily of metal subject to the conditions specified in the Schedule; and

- (b) under Sections 54(11)(a) and 56(12)(a) of the Act the Minister directed NIDA to register the Enterprise; and
- (c) the Enterprise was registered on 20th February, 1979.

#### **SCHEDULE**

#### Conditions of Registration—T. G. A. Pty Limited

- 1. (a) The registration of the Enterprise is for three years.
  - (b) If Papua New Guineans or local enterprises acquire beneficial ownership and control of not less than 51% of the Enterprise during the term of registration the registration shall not expire but shall continue for a further period of two years.

  - (b) Every year thereafter, the capacity is to be increased by one-fifth of the total designed accommodation until that total is reached.
- 5. Guest lounge, dining room, kitchen etc, shall be built to the full design capacity and equipped sufficiently to cater for the number of guests as laid out in 4(a) above, within two years of the date of grant, with such equipment being increased each year in accordance with 4(b) above.
