ADJUSTMENT OF MINIMUM WAGES UNDER THE MINIMUM WAGES BOARD DETERMINATION No. 1 OF 1980

- 1. The Consumer Price Index (C.P.I.) as calculated by the Bureau of Statistics has shown a percentage increase in the index for the combined September and December 1982 quarters, of 5.68 per cent.
- 2. Clauses 4.1 and 4.2 of the Determination prescribes the manner for calculating the increase of wages for the National Minimum Wage.
- 3. Clause 4.3 of the Determination prescribes the manner of calculating the increase of wages for the National Rural Minimum Wage.
- 4. Clause 4.4 of the Determination prescribes the date of effect of the increases in wages.
- 5. The National Minimum Wages payable with effect on and from 1st March, 1983 under the provisions of the Minimum Wages Board Determination No. 1 of 1980 are:
