Merchants Shipping Act 1975

REVOCATION AND FIXING OF SCALE FEES AND CHARGES

THE PAPUA NEW GUINEA HARBOURS BOARD, being a pilotage authority, by virtue of the powers conferred by Section 212 (2) of the *Merchant Shipping Act* 1975 and all other powers it enabling, hereby—

- (a) revokes the notice of fixing of Scale of Fees and Charges for Pilotage Services date—
 - (i) the 22nd June, 1977 and published in the National Gazette No. G54 of 30th June, 1977 as amended by the notice dated 16th February, 1979 and published in the National Gazette No. G30 of 17th May, 1979; and
 - (ii) the 21st March, 1977 and published in the National Gazette No. G29 of 31st March, 1977; and
 - (iii) the 14th November, 1978 and published in the National Gazette No. G95 of 30th November, 1978; and
 - (iv) the 22nd July, 1980 and published in the National Gazette No. G88 of 14th August, 1980; and
 - (v) the 23rd November, 1982 and published in the National Gazette No. G80 of 2nd December, 1982; and
- (b) fixes the following Scale of Fees and Charges for Pilotage services payable under Section 212 (1) of the Act.

A.—Scale of Fees and Charges Payable for Pilotage Services in respect of each Pilotage area specified in Schedule 1.

- 1. Pilotage Fees-Ships other than Ships licensed to engage in the Coasting Trade.
 - (a) From Sea-Berth—K1.00 per metre overall length From Sea-Anchorage—K1.00 per metre overall length
 - (b) From Berth to Sea—K1.00 per metre overall length From Anchorage to Sea—K1.00 per metre overall length
 - (c) Movements within the Port:
 - (i) Anchorage to Berth-K1.00 per metre overall length
 - (ii) Berth to Anchorage—K1.00 per metre overall length
 - (iii) Berth to Berth-K1.00 per metre overall length
 - (iv) Anchorage to Anchorage—50 Toea per metre overall length.
 - (d) where a Tug is towing or pushing another vessel or vessels, overall length shall be deemed to be the combined overall length of the Tug and the vessel or vessels being towed
- 2. Pilotage Fees-Ships Licensed to engage in the Coasting Trade-
 - (a) From Sea-berth—50 toea per metre overall length From Sea to Anchorage—50 toea per metre overall length
 - (b) From Berth to Sea—50 toea per metre overall length From Anchorage to Sea—50 toea per metre overall length
 - (c) Movements within the Port:
 - (i) Anchorage to Berth-50 toea per metre overall length
 - (ii) Berth to Anchorage—50 toea per metre overall length
 - (iii) Berth to Berth-50 toea per metre overall length
 - (iv) Anchorage to Anchorage—50 toea per metre overall length.
 - (d) Where a Tug is towing or pushing another vessel or vessels, overall length shall be deemed to be the combined overall length of the tug and the vessel or vessels being towed.
- 3. Pilotage Fees—Exempt Ships Licensed to engage in the Coasting Trade.

Exempt ships licensed to engage in the coastal trade of 80 metres overall length and over will pay 50 % the normal pilotage dues, when entering or leaving, or moving within a compulsory pilotage area.

4. Waiting Time.

Where a pilot is called for and if for any reason the ship is not ready to receive him, or is unable to proceed at the time the pilot arrives, a charge for pilot's waiting time is incurred up to a maximum of four hours.

Application for a Prospecting Authority-continued

- (a) Waiting time shall be paid at the rate of one (1) movement fee per hour or part thereof from the time the pilot is called for, with a minimum charge of K40.00 per hour.
- (b) Pilots employed by the Department of Transport and Civil Aviation shall be paid a fixed amount per hour or part thereof as may be determined by the Board, if the waiting time occurs outside normal working hours.
- (c) Privately employed pilots shall be paid a fixed amount per hour or part thereof as may be determined by the Board.
- 5. Payment of Pilotage Fees
 - (a) Pilotage Fees shall be payable to the Board which shall pay out such fees, any amount due to the pilots or their employers as the case my be.
 - (b) In the case of pilotage undertaken by licensed pilots not in the service of the Board 50% of the fees shall accrue to the Board and 50% shall be paid to the pilot at his principal place of business or residence.
- B.—Scale of charges for Pilotage Services in respect of each Port specified in Schedule 2.
 - 1. Where a pilot attending a port specified in Schedule 2 is absent from his principal place of duty for more than 12 hours a charge of K50.00 is payable for each 12 hours or part thereof.
 - 2. Where a pilot who, in order to attend a port specified in Schedule 2 takes passage in a ship at the request of the Master, a charge of K50.00 is payable for each period of 12 hours or part thereof that the pilot is absent from his principal place of duty.
 - 3. Paragraphs 1 and 2 do not apply if Private Licensed Pilots are engaged.

C.—Scale of charges for Pilot Boat Service in respect of each Port specified in Schedule 3.

- 1.—Ships, other than Ships Licensed to engage in the coasting Trade, shall pay.
 - (a) K60.00 Per Hour for the first hour or part thereof.
 - (b) K30.00 Per Half Hour for each subsequent half hour or part thereof.
 - (c) If the boat is hired—the actual cost of the hire.
- 2. Ships Licensed to engage in the coasting trade shall pay.
 - (a) K30.00 Per Hour for the first hour or part thereof.
 - (b) K15.00 Per Half Hour for each subsequent half hour or part thereof.
 - (c) If the Boat is hired—the actual cost of the hire.

- I, Phillip Bouraga, Minister for Finance, by virtue of the powers conferred by Section 17 of the Public Finances (Control and Audit) Act (Chapter 36) and all other powers me enabling, hereby—
