# Customs (Tariff) Act 1983

# **EXEMPTION FROM IMPORT DUTY**

#### APPLICATION FOR 15 CERTIFICATES OF REGISTRATION OF PUBLIC HIRE CARS AT PORT MORESBY

THE LAND TRANSPORT BOARD, by virtue of the powers conferred by the Motor Traffic Regulation (Chapter 243) and all other powers it enabling, hereby invites applications for the grant of 15 certificates of registration as public hire cars for the town of Port Moresby on the following terms and conditions:-

- 1. An applicant must-
  - (a) be engaged or about to be engaged solely in the business of operating private hire cars or public hire cars, as the case may be, or in that business or some other business jointly with; and
  - (b) a person of good character; and
  - (c) be a fit and proper person to hold a certificate of registration; and
  - (d) when required, furnish evidence to the Commissioner of Police as to the provisions of paragraphs (a), (b) and (c) hereof.
- 2. An applicant must, in his application-
  - (a) state his reason for requiring the grant of a certificate of registration; and
  - (b) give details of the matter referred to in Paragraph (a) of Condition 1; and
  - (c) fully document the economic viability of his proposal;
  - (d) state the make and model of vehicle proposed for registration; and
  - (e) where equity in the business is not wholly Papua New Guinean, state the full details of the company share holding structure including the basis on which Papua New Guinea equity is being established.
- 3. Applications may be objected by the Commissioner of Police and rejected by the Land Transport Board on the ground that the applicant does not comply with one or more of the matters referred to in Condition 1.
- 4. In the event of an objection to an application by the Commissioner of Police, the applicant will be given notice of the objection and the grounds therefor and will be afforded an opportunity to be heard on the objection.
- 5. Where a certificate of registration is granted to an applicant who is about to be engaged solely in the business of operating private hire cars or public hire cars, or in that business jointly with some other business, and that applicant does not so engage with a reasonable time after the grant, the Commissioner of Police may cancel the certificate of registration.
- 6. Applications must be in duplicate, enclosed in an envelope endorsed "Application for Public Hire Car Licence" and addressed to reach-
