TENDERS are invited for-Tender No. TC 20-38-37.

The Independent State of Papua New Guinea has the intention of proceeding with the first stage of the upgrading of the Enga Highway from Togoba to Tambul Turn-off. The first stage is the upgrading of the first 13.5 kilometres of the highway from Togoba. Financial assistance with the project may be provided by the International Bank for Reconstruction and Development.

The work consists of upgrading an existing gravel road in the Highlands and comprises earthworks, sub base, bridgeworks and drainage. It is intended to invite tenders from suitably qualified contractors for this project.

The magnitude of cost for the project is anticipated to be from Two Million Kina to Three Million Kina (January, 1984 K1=US\$1.145).

It is anticipated that invitations to tender will be issued during April, 1984 for construction to commence about November, 1984. Invitations to tender will be sent only to those Contractors who have been prequalified and whose interest has been registered with the Independent State of Papua New Guinea.

Contractors who are locally incorporated and are already qualified with the International Bank for Reconstruction and Development should apply again together with any other locally incorporated contractor who wishes to prequalify.

Prospective tenderers must be able to show relevant experience in projects involving highway construction and to show a history of successful contracts.
