ABOLITION AND ESTABLISHMENT OF DEPARTMENTS AND ALTERATION OF NAME OF DEPARTMENTS

I, Kingsford Dibela, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 12(2)(*a*), (*b*) and (c) of the *Public Service Act* (Chapter 67) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby—

- (a) abolish the Department of Physical Planning and Development; and
- (b) establish each Department set out in Schedule 1; and
- (c) alter the name of each Department specified in Column 1 of Schedule 2 to the name specified in Column 2 of that Schedule and set out opposite the name of the first mentioned Department in Column 1,

to come into effect on and from 1st March, 1985.
