The effect of this Order is to increase prices in line with the beer excise increase of 5%. The increases are—

- i. 333ml bottles in packs of 24's by 36 toea, 12's by 19 toea, and 6's by 10 toea.
- ii. 355ml Special Export in packs of 24's by 40 toea and 12's by 19 toea.
