## ABOLITION OF A DEPARTMENT AND, OFFICE OF A DEPARTMENTAL HEAD AND, ESTABLISHMENT OF DEPARTMENTS AND CREATION OF OFFICES OF DEPARTMENTAL HEAD

- I, Kingsford Dibela, G.C.M.G., K.St., J., Governor-General, by virtue of the powers conferred by Public Services (Management) Act 1986 and all other powers me enabling, acting with and in accordance with, the advice of the National Executive Council, hereby-
  - (a) in accordance with-
    - (i) Section 19(2)(b) of the Act, abolish the Department of Finance and Planning; and
    - (ii) Section 21(b) of the Act, abolish the Office of the Departmental Head of the Department of Finance and Planning; and
  - (b) in accordance with Section 19(2) (a) of the Act hereby establish—
    - (i) the Department of Finance; and
    - (ii) the Department of the Treasury; and
  - (c) in accordance with Section 21(a) of the Act hereby create—
    - (i) the Office of Departmental Head of the Department of Finance; and
  - (ii) the Office of Departmental Head of the Department of the Treasury.

Public Services (Management) Act 1986

REVOCATION OF APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEADS

I, Kingsford Dibela, G.C.M.G., K.St., J., Governor-General, by virtue of the powers conferred by Section 193(3) of the Constitution and Sections 25 and 26 of the Public Services (Management) Act 1986 and all other powers me enabling, acting with, and in accordance with, the advice of the National Exective Council, given after consultation with the Public Services Commission, hereby

- (a) revoke the appointment of Morea Vele as Secretary of the Department of Finance and Planning; and
- (b) appoint-
  - (i) Morea Vele to be the Secretary of the Department of Treasury; and
  - (ii) Gerea Aopi to be the Secretary of the Department of Finance,

with effect on and from the date of publication of this instrument in the National Gazette.

#### EXERCISE OF POWERS OF THE NATIONAL EXECUTIVE COUNCIL

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 149(4) of the Constitution and all other powers it enabling, hereby determines that the powers, functions, duties and responsibilities of the council in advising the Head of State in all matters relating to the appointment of Acting Secretary of the Law Reform Commission under Section 15 of the Law Reform Commission Act (Chapter 18) be exercised through the Minister for Justice.
