Curfew Act 1987

PROCLAMATION OF CURFEW

I, Ignatius Kilage, G.C.M.G., C.B.E., K.St.J., Governor-General, by virtue of the powers conferred by Section 3 of the *Curfew Act* 1987 and all other powers me enabling, acting with, and in accordance with the advice of the National Executive Council, hereby require every person within the boundaries of—

- (a) the City of Lae; and
- (b) the area including Busu, Burnayong, Soambu, Markham Bridge, to mouth of Markham River and back to Busu,

in Morobe Province to remain within doors between the hours of eight o'clock in the evening (8 p.m.) and five o'clock in the morning (5 a.m.) for a period of two months commencing on and from eight o'clock in the evening (8 p.m.) on Saturday, 11 November, 1989.
