MADE by the National Parliament to come into operation in accordance with a notice in the National Gazette by the Head of State, acting with, and in accordance with, the advice of the Minister.

1. PROVINCIAL LEGISLATURES (AMENDMENT OF SECTION 16).

Section 16 of the Organic Law on Provincial Government is amended by adding the following new subsections:—

- "(6) The elected members of a provincial legislature shall be elected at a general election held in accordance with Section 126(9) (elections) of the Constitution or from time to time at a by-election as the need arises.
- "(7) The provisions of any constitution for a province which are inconsistent with the provisions of Subsection (6) are, to the extent of the inconsistency, hereby amended to comply with the provisions of Subsection (6).".

2. REPEAL OF SECTION 113.

Section 113 of the Organic Law on Provincial Government is repealed.

Proposed Law to Alter the Organic Law on Provincial Government-continued

3. TRANSITIONAL PROVISIONS.

(1) In this section—

"the first general election" means the first general election to the Parliament and to provincial legislatures to be held after the coming into operation of this Law;

"the relevant period" means the period between the date of the coming into operation of this Law and the first general election;

"this law" means the Organic Law on Provincial Government (Elections) Law.

- (2) After the date of the coming into operation of this Law, the next general election of members of the provincial legislature for each province shall be the first general election, notwithstanding any provisions to the contrary in the constitution for any province.
- (3) Where, in accordance with the provisions of the constitution for a province, a general election of members of the provincial legislature for the province falls to be held during the relevant period, such geneal election shall be deferred until the first general election, and members of the provincial legislature holding office as at the date of the coming into operation of this Law shall, subject to their not being otherwise disqualified from holding such office under the constitution for the province or a Constitutional Law, continue to hold office until in relation to the first general election, they would otherwise have held office in relation to a general election of members of the provincial legislature.
- (4) Subject to Subsection (5), where in accordance with the provisions of the Constitution for a Province, a byelection of a member of the provincial legislature falls to be held during the relevant period, such by-election shall not be held and the vacancy shall not be filled until the first general election.
- (5) The provisions of Subsections (3) and (4) apply, notwithstanding that, in accordance with the provisions of the Constitution for a province, a writ for a general election to which Subsection (3) applies or for a by-election to which Subsection (4) applies has been prior to the coming into operation of this Law.
- (6) Where, as a result of the operation of Subsection (4), the number of offices of elected members remaining filled in a provincial legislature during the relevant period is less than the quorum for that provincial legislature, by-election shall be held to fill the vacancies and the members elected at such by-election shall hold office until, in relation to the first general election, they would otherwise have held office in relation to the next general election of members of the provincial legislature.
- (7) The Constitution for each province is hereby amended to the extent necessary to enable the provisions of this Law to take effect.

A Law to amend the Organic Law on National Elections,

MADE by the National Parliament to come into operation in accordance with a notice in the National Gazette by the Head of State, acting with, and in accordance with, the advice of the Minister.

1. INTERPRETATION (AMENDMENT OF SECTION 2).

Section 2(1) of the Organic Law on National Elections is amended—

- (a) by repealing the definition of "electorate" and replacing it with the following:—
 "'electorate' means an open electorate"; and
- (b) by adding the following definition:—

"'voter identification card' means a voter identification card issued under Section 54A".

2. PRIME FUNCTION OF THE ELECTORAL COMMISSION (AMENDMENT OF SECTION 15).

Section 15 of the Organic Law on National Elections is amended by adding the following:—
"and for provincial legislatures.".

3. REPEAL OF SECTION 33.

Section 33 of the Organic Law on National Elections is repealed.

4. REPEAL AND REPLACEMENT OF SECTION 34.

Section 34 of the *Organic Law on National Elections* is repealed and replaced with the following:— "OPEN ELECTORATES.

- (1) The number of open electorates shall be as determined by the Parliament, after considering a report of the Boundaries Commission, but in no case shall the number of open electorates be less than 99 or more than 109.
- "(2) There shall be at least two open electorates in each Province.".
- 5. SIZE OF OPEN ELECTORATES (AMENDMENT OF SECTION 35).

Section 2(b) of the Organic Law on National Elections is repealed.

6. DETERMINATION OF NEW ELECTORATES (AMENDMENT OF SECTION 40).

Section 40(1) of the Organic Law on National Elections is amended by repealing the words "together with the provincial electorates".

7. CLAIMS FOR ENROLMENT (AMENDMENT OF SECTION 54).

Section 54 of the Organic Law on National Elections is amended by repealing Subsection (1) and replacing it with the following:—

- "(1) Subject to this Section and to Section 51, a person who—
 - (a) (i) has resided in the area of an electorate for a period of not less than six months immediately preceding the date of his claim for enrolment; or
 - (ii) is nominated for an electorate for which he is not enrolled and was either born in the electorate or lived in the electorate for five years at any time; and
 - (b) appears before the Electoral Commission; and
 - (c) consents to be photographed and is photographed for the purpose of compiling a voter identification card.

is entitled to have his name placed on the Roll for that elecotrate.

8. NEW SECTION 54A.

The Organic Law on National Elections is amended by inserting after Section 54 the following new Section:—
"54A. VOTER IDENTIFICATION CARD.

(1) The Electoral Commission or a Returning Officer shall issue to a person entitled to have his name placed on the Electoral Roll in accordance with Section 54(1) a voter identification card in the prescribed form.

Proposed Law to Alter the Organic Law on National Elections—continued

- (2) A voter identification card—
 - (a) is valid until the Electoral Commission directs that a new Roll shall be prepared for the electorate specified on the voter identification card or until otherwise cancelled under this Part; and
 - (b) while remaining valid, entitles the person to whom it was issued to vote once in the elecotrate shown on it.
- "(3) Where—
 - (a) a person loses the voter identification card issued to him; or
 - (b) a voter identification card is destroyed,

the person to whom the voter identification card was issued may make application to the Electoral Commission or to a Returning Officer for a replacement voter identification card at any time up to seven days before the date fixed for polling, and the Electoral Commission, where he is satisfied that the voter identification card has been lost or destroyed, shall issue a new voter identification card to the person.

- "(4) A person who, in accordance with this part, makes a claim for transfer of enrolment, shall submit his voter identification card with his claim, and where the Returning Officer is satisfied that the person is entitled to a transfer of enrolment he shall—
 - (a) cancel the voter identification card submitted; and
 - (b) issue to the person a new voter identification card in accordance with Section 57(1)(d).
- "(5) A person, to whom a voter identification card has been issued, who changes his name from the name shown on the card, may submit his voter identification card to the Electoral Commission with an application for a replacement voter identification card, and where the Electoral Commission is satisfied that the name of the person has been changed, he shall—
 - (a) cancel the voter identification card submitted; and
 - (b) issue to the person a new voter identification card in the name as changed."

9. REGISTRATION OF CLAIM (AMENDMENT OF SECTION 57).

Section 57(1) of the Organic Law on National Elections is amended by inserting immediately after Paragraph (c) the following:—

"(d) in the case of a transfer of enrolment, issue a new voter identification card to the claimant.".

10. NOTIFICATION OF REJECTION OF CLAIM (AMENDMENT OF SECTION 58).

Section 58 of the Organic Law on National Elections is amended by adding the following new subsection:—

"(2) In the case of the rejection of a claim for transfer of enrloment, the Returning Officer, when notifying the claimant under Subsection (1), shall return to the claimant the voter identification card submitted with the claim.".

11. INCORRECT ENROLMENT (AMENDMENT OF SECTION 63).

Section 63 of the *Organic Law on National Elections* is amended by adding the following words:— "and cancel the voter identification card issued to that person.".

12. DETERMINATION OF OBJECTION (AMENDMENT OF SECTION 70).

Section 70 of the Organic Law on National Elections is amended by repealing Subsection (1) and replacing it with the following:—

- "(1) Subject to Subsection (2), the Returning Officer shall determine an objection under this Part as soon as practicable after receipt by him of the answer of the person objected to, or, if no answer is received within a period of one month after the posting or delivery of the notice referred to in Section 68(1) and if it appears that the person objected to is not entitled to be enrolled on the Roll in respect of which the objection has been made, the Returning Officer shall—
 - (a) remove the name of the person from the Roll; and
 - (b) cause a copy of the notice of determination to be posted to or served on the objector and the person objected to; and
 - (c) cancel the voter identification card issued to the person objected to.".

13. FORM OF WRITS (AMENDMENT OF SECTION 74).

Section 74(1)(b) of the Organic Law on National Elections is amended by adding the following words:— "which period shall not exceed 14 days;".

14. DATE OF NOMINATION (AMENDMENT OF SECTION 77).

Section 77 of the Organic Law on National Elections is amended by repealing the figures and word "42 days" and replacing them with the following:—

"35 days".

15. REQUISITES FOR NOMINATION (AMENDMENT OF SECTION 86).

Section 86(c) of the Organic Law on National Elections is amended by repealing the letter and figures "K100.00" and replacing them with the following:—

"K1 000.00".

16. REPEAL AND REPLACEMENT OF SECTION 89.

Section 89 of the Organic Law on National Elections is repealed and is replaced with the following:—
"89. DEPOSIT TO BE FORFEITED IN CERTAIN CASES.

The deposit made by or on behalf of a candidate at an election shall be retained pending the election, and after the election shall be returned to the candidate, or to some person authorized by him in writing to receive it, if he is elected, and otherwise it is forfeited to Papua New Guinea.".

17. FAILURE OF ELECTION (AMENDMENT OF SECTION 96).

Section 96(2) of the Organic Law on National Elections is repealed and is replaced with the following:—

"(2) An election shall be deemed to have failed if no candidate is nominated or returned as elected.".

18. REPEAL AND REPLACEMENT OF SECTION 133.

Section 133 of the Organic Law on National Elections is repealed and is replaced with the following:—
"133. PERSONS CLAIMING TO VOTE TO GIVE NAME, ETC., AND TO EXHIBIT VOTER IDENTIFICATION CARD.

- (1) A person claiming to vote at a polling booth shall—
 - (a) exhibit the voter identification card issued to him; and
 - (b) state his full name or names; and
 - (c) if so desired by the presiding officer for the purpose of identifying the name under which the vote is claimed, any other particulars necessary to be stated in the Roll or to enable him to be identified in the Roll.
- (2) If a person claiming to vote at a polling booth—
 - (a) fails to exhibit the voter identification card issued to him; or
 - (b) exhibits a voter identification card which—
 - (i) is no longer valid; or
 - (ii) does not entitle the person to vote in the electorate to which the polling booth relates; or
 - (iii) has already been marked under Section 137 for the election in which the person is claiming to vote.

his claim to vote shall be rejected unless he is a candidate for election for that electorate.".

19. REPEAL AND REPLACEMENT OF SECTION 135.

Section 135 of the Organic Law on National Elections is repealed and is replaced with the following:—"135. CERTAIN ERRORS NOT TO FORFEIT VOTE.

No error or omission in the Roll for a electorate of part of a name or entry of a wrong name, address or occupation and no mistake in the spelling of a name warrants the rejection of a claim to vote, and no person shall be disqualified from voting under the name appearing on the Roll because of a change of name if—

- (a) the person claiming to vote exhibits a valid voter identification card for the electorate; and
- (b) in the opinion of the presiding officer, the person is sufficiently identified.".

20. REPEAL AND REPLACEMENT OF SECTION 137.

Section 137 of the Organic Law on National Elections is repealed and is replaced with the following:—
"137. LIST OF VOTERS AND VOTER IDENTIFICATION CARD TO BE MARKED ON ISSUE OF BALLOT PAPER.

Immediately upon handing the ballot-paper to a person claiming to vote, the presiding officer or a poll clerk shall—

- (a) place a mark against the person's name on the certified list of voters; and
- (b) place the prescribed mark on the person's voter identification card.".

21. REPEAL AND REPLACEMENT OF SECTION 140.

Section 140 of the *Organic Law on National Elections* is repealed and is replaced with the following:— "140. ASSISTANCE TO CERTAIN VOTERS.

- (1) If a voter satisfies the presiding officer that—
 - (a) his sight is impaired; or
 - (b) that he is so physically incapacitated that he is unable to vote without assistance; or
 - (c) that he is so illiterate that he is unable to vote without assistance,

the presiding officer shall permit a person appointed by the voter to enter an unoccupied compartment of the booth with the voter, and mark, fold and deposit the voter's ballot-paper for him.

- (2) If a voter referred to in Subsection (1) fails to appoint a person under that subsection, the presiding officer, in the presence of—
 - (a) if the voter so desires, a person appointed by the voter for the purpose; or
 - (b) in the absence of any such appointment, the poll clerk, shall mark, fold and deposit his ballot-paper for him.

Proposed Law to Alter the Organic Law on National Elections-continued

(3) A person appointed under Subsection (1) to assist a voter shall refrain from disclosing any knowledge of the vote of the voter.

Penalty: A fine of K400.00 or imprisonment for a term not exceeding three months.".

22. REPEAL OF SECTION 141.

Section 141 of the Organic Law on National Elections is repealed.

23. BLIND OR PHYSICALLY INCAPACITATED VOTERS (AMENDMENT OF SECTION 144).

Section 144(1) of the Organic Law on National Elections is amended by repealing the words and figures "Sections 141, 142 or 143" and replacing them with the following:—

"Section 142 or 143".

24. DEALINGS WITH VOTERS, ETC., UNDER THIS DIVISION (AMENDMENT OF SECTION 145).

Section 145(1) of the Organic Law on National Elections is amended by repealing the words and figures "Sections 141, 142 or 143" and replacing them with the following:—

"Section 142 or 143".

25. REPEAL AND REPLACEMENT OF SECTION 151.

Section 151 of the *Organic Law on National Elections* is repealed and is replaced with the following:—"151. SCRUTINEERS AT SCRUTINY.

- (1) A candidate may appoint one or more scrutineers to represent him at the scrutiny, but only one such scrutineer for each candidate may be present in the counting centre at any one time during the scrutiny.
 - (2) The appointment of a scrutineer under this section to represent a candidate at a counting centre—
 - (a) shall be made by notice in writing signed by the candidate, or by telegram signed by the candidate before it is tendered for transmission, given or sent to the officer who is to conduct, or who is conducting, the scrutiny at the counting centre; and
 - (b) shall specify the name and address of the scrutineer.".

26. RETURN OF THE WRITS (AMENDMENT OF SECTION 176).

Section 176(2) of the Organic Law on National Elections is amended by repealing the words and figures "Sections 141, 142 or 143" and replacing them with the following:—

"Section 142 or 143".

27. DISPLAY OF CERTAIN ELECTORAL POSTERS PROHIBITED (AMENDMENT OF SECTION 183).

Section 183 of the Organic Law on National Elections is amended by repealing Subsection (1).

28. NEW SECTION 184A.

The Organic Law on National Elections is amended by inserting after Section 184 the following new section:— "184A. LOUD-HAILERS, ETC.,

(1) Subject to Subsection (2), a person, who uses a loudhailer, megaphone or other similar device during the polling period, is guilty of an offence.

Penalty: K500.00.

(2) Subsection (1) does not apply to a police officer or electoral officer who uses a loud-hailer, megaphone or other similar device for the purposes of maintaining order or giving instructions.".

29. REQUISITES OF PETITION (AMENDMENT OF SECTION 208).

Section 208(e) of the Organic Law on National Elections is amended by repealing the words "two months" and replacing them with the following:—

"six months".

A Law to alter the provisions of the Constitution relating to elections,

MADE by the National Parliament to come into operation in accordance with a date fixed in the National Gazette by the Head of State, acting with, and in accordance with, the advice of the Prime Minister.

1. MEMBERSHIP (AMENDMENT OF SECTION 101).

Section 101 of the Constitution is amended—

- (a) in Subsection (1), by repealing Paragraph (b); and
- (b) in Subsection (2), by repealing the words "and provincial"; and
- (c) in Subsection (4), by repealing the words "and of provincial electorates".

2. QUALIFICATIONS FOR AND DISQUALIFICATIONS FROM MEMBERSHIP (AMENDMENT OF SECTION 103).

Section 103 of the Constitution is amended—

- (a) in Subsection (1) by repealing the figures and words "25 years of age" and replacing them with the following:—
 - "30 years of age"; and
- (b) in Subsection (2), by adding the following words:—
 "and must pay a nomination fee of K1 000.00".

3. BY-ELECTIONS (AMENDMENT OF SECTION 106).

Section 106(a) of the Constitution is amended by repealing the words "six months" and replacing them with the following:—

" months".

4. , ALLING, ETC., (AMENDMENT OF SECTION 124).

Section 124(1) of the Constitution is amended by repealing the figures and words "21 days" and replacing them with the following:—

7. RE-ESTABLISHMENT OF PROVINCIAL GOVERNMENT (AMENDMENT OF SECTION 187F).

Section 187F of the Constitution is amended—

- (a) in Subsection (1), by repealing the words and numbers "Subsections (2) and (3)" and replacing them with the following:-
 - "Subsections (2), (3), (5) and (6)"; and
- (b) by adding the following subsections:—
 - "(5) Where—
 - (a) in pursuance of Subsection (1) an election is required to be held; and
 - (b) but for the operation of this subsection the date fixed for the return of the writs in such election would fall within the period of six months before the fifth anniversary of the date fixed for the return of the writs for the previous general election to the National Parliament,

such election shall not be held but shall be deffered until the date of the next general election, and, notwithstanding any other provisions of this Constitution, the suspension shall continue in effect until the date fixed for the return of writs in that next general election.

Proposed Law to Alter the Constitution-continued

- "(6) Where—
- (a) in pursuance of Subsection (1) a writ for an election has been issued; and
- (b) after the writ for the election has been issued and before the day fixed for the return of that writ, writs for a general election to the parliament are issued, the first-mentioned writ shall be deemed to have been revoked.
- "(7) Persons elected to a provincial legislature under this section are elected for the period until the next elections under Section 126(9) (elections).".
