### REDUCED RATES OF IMPORT DUTY

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the Customs Tariff Act 1990 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby reduce the rates of import duty, with effect from the date of publication of this notice in the National Gazette, on goods specified in the Schedule subject to such conditions as are specified in the Schedule:—

# **EXEMPTION FROM IMPORT DUTY**

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the Customs Tariff Act 1990 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from import duty, with effect from the date of publication of this instrument in the National Gazette, the goods mentioned in the Schedule subject to such conditions as are specified in the Schedule.

### Exemption from Import Duty—continued

### **SCHEDULE**

# Description of goods and any other conditions

- 1. Specialised equipment of the kind specified below (other than goods of a consumable nature or goods available in Papua New Guinea) when imported for use in approved exploration for minerals provided that security to the satisfaction of the Commissioner-General is executed by the importer and the goods are exported at the end of the period specified for the exploration activity:-
  - (a) Drilling Rigs, including Diamond drills, Percussion drills, Auger drills, Cable Tool Drills/Banka drills, Reverse circulation (RC) drills, Wacker drills;
  - (b) Drilling Equipment, including down hole (Borehole) directional equipment, bore hole surveying equipment, down the hole probes, drill pipe recovery equipment, booster compressors;
  - (c) Petrographic or polarizing microscopes, stereoscopes, microscopes, sterescope microscopes, Global Positioning System equipment;
  - (d) Radiometers, including spectrometer (airborne spectrometer, borehold spectrometer), geiger counter, scintillometers;
  - (e) Electrical equipment, including induced polarisation, resistivity, self potential, telluric, magnetelluric;
  - (f) Gravitometers (airborne gravitometer or borehole gravitometer);
  - (g) Seismic equipment, including geophones, seismographs, seismic hammer;
  - (h) Magnetometers, including magnetometer, fluxgate magnetometer, schmidt field balance, dip needle;
  - (i) Electromagnetic equipment (EM) including airborne EM equipment, VLF (Very low frequency) equipment, ground EM equipment, borehole (down the hole) logging equipment;
  - (j) Electromagnetic equipment (EM) including airborne (EM) equipment, VLF (Very low frequency) equipment, ground EM equipment; and
  - (k) Infra Red (IR) scanners, Remote Sensing Scanners, Side looking Airborne Radar (SLAAR).
- 2. Specialised equipment of the kind specified below (other than goods of a consumable nature or goods available in Papua New Guinea) when imported for use in approved exploration for petroleum or gas provided that security to the satisfaction of the Commissioner-General is executed by the importer and the goods are exported at the end of the period specified for the exploration activity:-
  - (a) Rig and equipment including derrick, substructure, engines, pumps, well control equipment;
  - (b) Drilling tools including drill pipes, collars, stabilisers, reamers, bits, directional drilling tools, etc.;
  - (c) Logging equipment and associated tools including mud logging computers and equipment, wireline logging/perforation equipment and tools;
  - (d) Well testing equipment and associated tools;
  - (e) Workover equipment and tools (Workover rigs and associated equipment and tools, wireline workover tools and instrument);
  - (f) Support and supply vessels for offshore drilling activity including towed barges, supply boats, wareships, workboats, support boats;
  - (g) Mobile offshore drilling units including completely equipped drillships, semi-submersible, submersible, submersible and barged drilling units and jack-up rigs;
  - (h) Seismic acquisition including geophones, cables, telemetry units, recording instruments, in-field processing units; and
  - (i) Other geophysical equipment including gravimeters, magnettometers, and magnetotelluric equipment.
- 3. Capital equipment, being plant or machinery, or substantial components thereof, provided that approval for importation has been given by the Commissioner-General being satisfied that the equipment is for the purpose of establishment of a new industry or the expansion of an existing industry, and that the equipment is not available in Papua New Guinea.

# REVOCATION OF REDUCTION OF RATE OF IMPORT DUTY AND SUBSTITUTION OF REDUCED RATE OF IMPORT DUTY

- I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the Customs Tariff Act 1990 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby, in respect of the goods specified in Serial No. 3 of the Schedule to the Reduced Rate of Duty Notice dated 10th November, 1992 and published in National Gazette No. G94 (page 5) on 13th November, 1992, with effect from the date of publication of this instrument in the National Gazette—
  - (a) revoke the reduction to 10% of the rate of import duty; and
  - (b) substitute a reduced rate of import duty of 30%.

### AMENDMENT OF EXEMPTION FROM IMPORT DUTY

I, Wiwa Korowi, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the Customs Tariff Act 1990 and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby vary, in accordance with the Schedule hereto, the notice of exemption from payment of import duty dated 8th October, 1993 and published in National Gazette No. G85 on 14th October, 1993 (said notice being referred to in the Schedule hereto as "the original notice"), as follows:—

### **SCHEDULE**

- (a) The reference in Paragraph (a) of the Schedule to the original notice to "11 MW Gas Turbines" is varied to "11.6 MW Gas Turbines".
- (b) The reference in Paragraph (e) of the Schedule to the original notice "Diesel" is varied to "Diesel Spare Parts".
