**NOTICE UNDER SECTION 29 (TAKING OF PROTECTED ANIMALS FOR SPECIAL PURPOSE)**

I, Parry Zeipi, Minister for Environment and Conservation, by virtue of the powers conferred by Section 29 of the *Fauna (Protectin and Control) Act (Chapter 154)* and all other powers me enabling, hereby allow the taking of the Birdwing butterflies known as *Orithoptera meridionalis* and *Ornithoptera Paradisea* by—

- (a) the Insect and Farming Trading Agency of Papua New Guinea University of Technology for the purpose of farming, buying, selling, offering or consigning for sale overseas specimens (both live and dead); and
- (b) persons selected by the said Agency and approved by the Conservator of Fauna as butterfly farmers for the purpose of farming and selling to the said Agency, and that subject to the condition contained in the Schedule.

**SCHEDULE**

**CONDITIONS**

1. Only farmed specimens may be sold, bought or exported.
2. All farmed specimens to be marked through the Insect Farmin and Trading Agency.
3. A percentage, as set and nominated by the Insect farming and Trading Agency, of adult specimens be released by farmers to ensure the maintenance of a viable breeding population.
4. That, where appropriate, areas of natural habitat be set aside by the farmers for the conservation of the species to ensure the long term protectin of the butterflies covered by this Instrument.
5. The Insect Farming and Trading Agency shall elect person as butterfly farmers and shall submit their names to the Conservator of fauna for approval prior to their commencing farming.
6. The Insect Farming and Trading Agency may only export in any one year up to an annual quota of 500 pairs of *O. meridionalis* and 1,000 pairs of *O. paradisea*.
