Citizenship Act (Chapter 12)

APPOINTMENT OF CHAIRMAN, DEPUTY CHAIRMAN AND PERMANENT MEMBERS OF THE **CITIZENSHIP ADVISORY COMMITTEE**

I, Bill Skate, MP., Acting Governor-General, by virtue of the powers conferred by Sections 75 of the Constitution and 10(3) of the Citizenship Act (Chapter 12) and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Permanent Parliamentary Committee, hereby—

- appoint Paul Mambei, a member of the Parliament, to be a permanent member and Chairman of the (a)Citizenship Advisory Committee; and
- appoint Mathias Karani, a member of the Parliament, to be a permanent member and Deputy Chairman of **(b)** the Citizenship Advisory Committee; and
- re-appoint Gabriel Dusava to be permanent member of the Citizenship Advisory Committee; and **(***C***)**
- appoint Sao Gabi to be permanent member of the Citizenship Advisory Committee. (d)

Public Services (Management) Act 1986

REVOCATION OF APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEADS

I, Bill Skate, MP., Acting Governor-General, by virtue of the powers conferred by Section 193(3) of the Constitution and Sections 24, 25, and 26 of the Public Services (Management) Act 1986, acting with, and in accordance with, the advice of the National Executive Council, given after consultation with the Public Services Commission, hereby—

- revoke the appointment of Utula Samana as Secretary, Department of Agriculture and Livestock dated (a) 4th November, 1993 and published in the National Gazette No. G92 of 11th November, 1993; and
- revoke the appointment of Miri Setae as Acting Secretary, for Department of Agriculture and Livestock; *(b)* and
- (c) promote and appoint Miri Setae to be Secretary, Department of Agriculture and Livestock for a period of four years,
