STATUTORY INSTRUMENT

Customs (Prohibited Imports) (Amendment) Regulation 1994

being

A Regulation to amend the Customs (Prohibited Imports) (Amendment) Regulation (Chapter 101),

MADE by the Head of State, acting with, and in accordance with, the advice of the Minister under the *Customs Act* (Chapter 101).

AMENDMENT OF SCHEDULE 2.

Schedule 2 of the Principal Regulation is amended by inserting after Item 85 the following new Item—

"85A. Fish (Mackerel), canned Goods (except those imported by Pacific Fish Cannery Pty. Ltd) shall not be imported into Papua New Guinea except where:—

- (a) the importer, on presentation of documentary evidence or on statutory declaration to the Commissioner-General of Internal Revenue, satisfies the Commissioner-General that he has purchased from Pacific Fish Cannery Pty. Ltd canned mackerel amounting to at least 25% of the amount proposed to be imported; and
- (b) the quota for importation has been approved by the Minister responsible for foreign affairs and trade matters or by the Minister responsible for commerce and industry matters."
